#### MORTGAGE MODIFICATION AGREEMENT

THIS MORTGAGE MODIFICATION AGREEMENT made and entered into as of the 3rd day of FEBRUARY , 1992 by and between PATRICK H. HAGERTY III and ELEANORA HAGERTY, his wife ("Borrower"), and Community Bank and Trust Company of Edgewater, a State Banking Corporation, with its office located at 5340 N. Clark Street, Chicago, Illinois 60640 ("Bank").

#### WITNESSETH THAT:

Borrower has executed and delivered a Home Equity Line of Credit Agreement and Disclosure Statement (the "Agreement") dated DECEMBER 20, 1989 with a Maximum Credit Amount in the amount of \$ 30,000.00 from Bank to Borrower; and

Borrower has delivered to Bank a Mortgage (the "Mortgage")

- In all other respects except as modified herein, the Loan Documents remain unmodified and in full force and effect.
