Such certified copies may be obtained ONLY from the Secretary of State
- Any change of registered agent must be by resolution adopted by the board of directors. This statement mi then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary).
- The registered agent may report a change of the registered office of the corporation for which he or she registered agent. When the agent reports such a change, this statement must be signed by the register agent.
