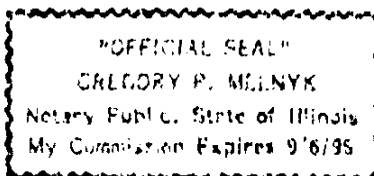

LAST WILL AND TESTAMENT

OF

I, JEAN J. GRECO, now residing in the Village of Bellwood, County of Cook and State of Illinois, being of sound and disposing mind and memory, do hereby make, publish and declare this my Last Will and Testament.

ARTICLE I

I hereby expressly revoke any and all other and former wills and testamentary instruments heretofore made by me, and particularly declare this to be my Last Will and Testament.

ARTICLE II

I hereby direct and provide that all my just debts and all obligations of my estate arising in the course of administration thereof or otherwise shall be first paid or provided for before any other distribution under the terms of this Will. All charges in the nature of inheritance, estate or succession taxes or death duties, whether against my estate or against the succession or interest of any beneficiary hereunder or assessed in any way by reason of my death, shall be paid by my Executor from the principal of my estate as an expense of administration chargeable against my estate generally.

ARTICLE III

I give, devise and bequeath all the estate and effects whatsoever and wheresoever real, personal and mixed to which I may be entitled or which I may have power to dispose of at my decease, to my lawful descendants who survive me, per stirpes. My only children now living are my son, JAMES GRECO and my daughter DONNA JEAN IMBROGNO.

ARTICLE IV

I hereby nominate and appoint my son, JAMES GRECO, or if he dies resigns or refuses or is unable to act, my daughter, DONNA JEAN IMBROGNO, to be Executor of this my Last Will and Testament. I direct that my Executor shall not be required to give any security or surety on his or her bond as Executor.
