WHEREAS

FIRST SAVINGS AND LOAN ASSOCIATION OF SOUTH HOLLAND
loaned BEVERLY TRUST COMPANY, AS TRUSTEE UNDER TRUST AGREEMENT DATED JUNE 20, 1985
AND KNOWN AS TRUST NO. 8-7933

the sum of ONE HUNDRED SEVENTY SIX THOUSAND FOUR HUNDRED AND NO/100ths----- Dollars

(\$ 176,400.00) as evidenced by a note and mortgage executed and delivered on May 20, 1991
which mortgage is duly recorded in the public records in the jurisdiction where the mortgaged property is located, which
note and mortgage are hereby incorporated herein as a part of this instrument, and

WHEREAS, the undersigned, owner of said premises, has found it necessary and does hereby request a modification of the
terms of said loan for the following reasons:

to reduce the interest rate to 7-3/4% from 9-1/8%, said reduction in interest
to be effective with the payment due February 1, 1992.

Mortgagors agree to pay a Modification Fee of \$1,730.98 which is 1% of
the current principal balance.

EXHIBIT "A" CONTAINING LEGAL DESCRIPTION ATTACHED HERETO AND MADE A PART HEREOF;
AND WHEREAS, the parties desire to reduce the modified terms of said loan so that there shall be no misunderstanding of
the matter;

THEREFORE, it is hereby agreed that, as of the date of this Agreement, the unpaid balance of said indebtedness is

ONE HUNDRED SEVENTY THREE THOUSAND NINETY EIGHT AND 91/100ths----- Dollars (\$ 173,098.91),

all of which the undersigned promises to pay with interest at 7-3/4 % per annum until paid, and that the

same shall be payable SIXTEEN HUNDRED SIXTY FOUR AND 43/100ths----- Dollars (\$ 1,664.43),

per month beginning on the 1st day of February 19 92, to be applied first to interest,

and balance to principal, plus a sum estimated to be sufficient to discharge taxes and mortgage obligations (which estimated
sum may be adjusted as necessary) and that in all other respects said mortgage contract shall remain in full force and effect.
