Party(ies) of the second part promise to pay to party of the first part, the legal owner and holder of the note hereinabove described, at its offices in the Village of Winnetka or at such other place as party of the first part shall designate in writing the remaining unpaid principal balance of said installment note which balance, as of the date hereof is TWENTY THOUSAND AND NO/100 pollars (\$20,000.00), together with interest from FERNDARY 15, 1992 on the balance of principal remaining from time to time at a rate of 8.50% as follows: TWO HUNDRED FIFTY ONE AND 96/100 DOLLARS (\$251.96) on the 15th day of MARCH, 1992, and TWO HUNDRED FIFTY ONE AND 96/100 DOLLARS (\$251.96) on the 15th of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooned paid, shall be due on the 15th day of NOVEMBER, 2001;
