Inc. in hand paid, the said Jenner & Block Individual Retirement Income Plan No. 25 does hereby covenant and agree with the said First American Bank that the lien of the note owned by said Jenner & Block Individual Retirement Income and of the mortgage securing the same shall be and remain at all times a second lien upon the premises thereby conveyed subject to the lien of the mortgage to said First American Bank as aforesaid for all advances made or to be made on the note secured by said last named First American Bank and for all other purposes specified therein.
