THIS INDENTURE, made February 24, 19 92, between ANTHONY RAGONA and DEBORAH RAGONA, his wife,

herein referred to as "Mortgagors", and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of

ONE HUNDRED THOUSAND (\$100,000.00) ----- Dollars, evidenced by one certain Instalment Note of the Mortgagors of even date herewith, made payable to THE ORDER OF BEARER

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum in instalments as follows:

EIGHT THOUSAND FIVE HUNDRED (\$8,500.00) ----- Dollars or more on the 24th day of February, 19 93, and EIGHT THOUSAND FIVE HUNDRED (\$8,500.00) Dollars or more on the 24th day of February thereafter, to and including the 24th day of February, 1997

with a final payment of the balance due on the 24th day of February, 1997, with interest from February 24, 1992 on the principal balance from time to time unpaid at the rate of 8 1/2 per cent per annum; each of said instalments of principal bearing interest after maturity at the rate of 18 per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in Chicago, Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of NICK GAGLIANO and FRIEDA GAGLIANO, 10166 N.W. 1st Manor, Coral Springs, FL. 33074, said City,

NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the City of Chicago, COUNTY OF COOK, AND STATE OF ILLINOIS to wit:

Lot 6 in Pontarelli's Lawrence Avenue Resubdivision, being a resubdivision of part of Lots 11 and 12 in Block 2 in Frederick H. Bartlett's Lawrence Avenue Subdivision in the Northwest 1/4 of Section 17, Township 40 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by the mortgagors or their successors or assigns shall be considered as constituting part of the real estate.

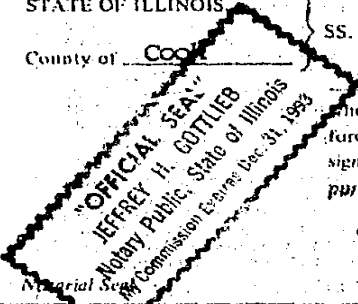
