NOTE MODIFICATION AGREEMENT

 - a) The payments on account of principal and interest of said note shall become due and payable as follows:

The loan to be extended for a fifty-eight month period. Principal and accrued interest are due and payable in monthly payments of \$2,068.97 plus interest on the 27th day of each month, beginning Feburary 27, 1992. The last scheduled payment of unpaid principal and interest will be December 27, 1996. Unless paid sooner all unpaid principal and accrued interest shall be due and payable on December 27, 1996.

4. The foregoing modification shall be effective as of the date hereof, all other provisions of the note shall remain in full force and effect.
