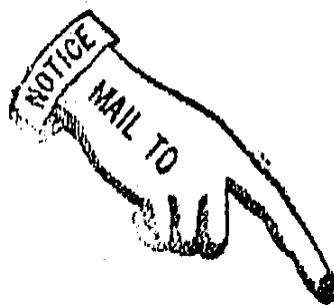
EXHIBIT "A"
