That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated february 3 199> reflecting and securing the loan made by Mortgagee to Borrowers, in the amount of One Hundred Fighty Six Thousand\* Dollars, and to all renewals, extensions or replacements of said Mortgagee's mortgage; and \*Six Hundred and no/100
- 2. That this Agreement shall be binding upon and shall inure to the benefit of Mortgagee, its successors and assigns.
