WHEREAS, the Senior Lender is the owner and holder of that certain mortgage (the "Senior Mortgage") securing a loan in an amount equal to \$14,000,000 (the "Senior Loan") and encumbering the Property.

WHEREAS, the Trustee desires to obtain or has obtained a mortgage (the "Subordinate Mortgage") in favor of the Subordinate Lender, which Subordinate Mortgage is to be junior and subordinate to the Senior Mortgage and is to encumber the Property.

WHEREAS, the Subordinate Lender desires to be the owner and holder of the Subordinate Mortgage granted or to be granted by Trustee, securing a loan in an amount not to exceed \$6,500,000 (the "Subordinate Loan") and encumbering the Property.

WHEREAS, as a condition of Trustee being permitted to further encumber the Property with the Subordinate Mortgage and Senior Lender approving said Subordinate Mortgage, Senior Lender has required Subordinate Lender to enter into that certain Subordination and Intercreditor Agreement of even date herewith (the "Intercreditor Agreement").

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties hereto, the parties hereto agree as follows:

1. Intercreditor Agreement. The Senior Lender and Subordinate Lender have entered into the Intercreditor Agreement (as defined above).
2. Notice to Third Parties. By the execution and recording of this Memorandum, the parties hereto desire to give notice to third parties of the existence of the Intercreditor Agreement and certain terms thereof.
3. Conflict. In the event of a conflict between this Memorandum and the Intercreditor Agreement, the Intercreditor Agreement shall control.
4. Governing Law. This Memorandum shall be governed by and construed under the laws of the State of Illinois.
5. Counterparts. This Memorandum may be executed in any number of counterparts, and all such counterparts shall constitute one (1) and the same document.

6. Release. This Memorandum shall be ^{deemed} released and ^{automatically} terminated concurrently upon the payment in full of the indebtedness secured by the Senior Mortgage and the satisfaction and release of the Senior Mortgage.






