ORDINANCE NO. 706

ORDINANCE PROVIDING FOR ESTABLISHMENT OF SPECIAL CONNECTION CHARGES TO THE COUNTY LINE ROAD WATER MAIN

BE IT ORDAINED by the President and Board of Trustees of the Village of Burr Ridge, DuPage and Cook Counties, Illinois, as follows:

Section 1: This Board of Trustees finds as follows:

A. This Village (hereinafter referred to as the "VILLAGE") owns, operates, and maintains a Waterworks system and that the system has been expanded and extended by construction of a certain water main and ancillary facilities along County Line Road from North of 80th Street to 8200 South (hereinafter referred to as the "Water Main"), as more specifically described in certain plans and specifications on file in the office of the Village Clerk as prepared by Frank Novotny and Associates, Inc.

B. The completion of the Water Main was authorized by the Board of Trustees and was constructed at a cost in the amount of \$74,217.17.

C. No special assessment or special taxes have been levied in connection with said construction, and it is in the public interest that the cost of construction be paid by special connection charges to property owners at such time as they elect to connect to the Water Main in accordance with Section 11-150-1 of the Illinois Municipal Code.

Section 2: The special connection charges provided for by this Ordinance shall be applicable to the properties described in this Ordinance.

Section 3: The VILLAGE hereby determines that it will require as a condition to connection to and use of the Water Main relating to or benefiting any lot or parcel described in EXHIBIT A, attached hereto and made a part hereof, the annexation of said lot or parcel to the Village.

Section 4: The VILLAGE further determines that it will, to the extent the same is permitted by law, require that as a condition to the VILLAGE's permitting any connection to and use of the Water Main relating to or benefiting any properties identified on EXHIBIT A, the owner or owners of said properties to pay to the VILLAGE a special connection charge.

Section 5: The special connection charges for any lot or parcel of real estate described in EXHIBIT A, are hereby established and set forth in EXHIBIT A. Connections to the Water Main will be permitted only for real estate which lies within the corporate boundaries of said VILLAGE and only for after payment of said special connection charge. In addition, the only connections permitted to the Water Main will be single-family residences unless other connections are approved by separate agreement with the VILLAGE OF BURR RIDGE.

Section 6: The special connection charges shall be increased by a \$200.00 administrative fee and interest shall accrue thereon at the rate of seven percent (7%) of the original connection charge established by this Ordinance for any property owner which has not chosen to connect to the Water Main within thirty (30) days of the adoption hereof. Such charge shall be so increased by seven

percent (7%) commencing on January 1 of 1993 and also an additional seven percent (7%) each year thereafter extending to and including January 1, 1997. Thereafter no further interest shall accrue.

Section 7: The special connection charges are in addition to the general water connection fees or charges established from time to time by Village ordinance, and the owners of the parcels of property described in said EXHIBIT A shall, in addition to the charges established herein, remain responsible for such other connection fees and charges and all other fees established by applicable Village ordinances.

Section 8: This ordinance shall be in full force and effect, from and after its adoption and approval as provided by law. The Village Clerk is directed to record a copy of this Ordinance with the Recorder of Deeds of DuPage County, Illinois, and also with the Recorder of Deeds of Cook County, Illinois.


