This Note and Trust Deed Modification Agreement (this "Agreement") is made and entered into as of this 5th day of February, 1992 by and between Robert L. Leopold, Jr. ("Borrower"), and Viola G. Leopold, Robert L. Leopold, Jr., Thomas M. Leopold, Richard L. Freeman and Chicago Title and Trust Company, as Trustees of the Robert L. Leopold Marital Trust ("Lender").

## RECITALS:

- Lender has loaned to Borrower an amount in the principal sum of \$225,000.00 (the "Loan") as evidenced by that certain Note dated as of June 1, 1988, made by Borrower in favor of Lender (the "Note").
- B. The Note is secured by that certain Trust Deed dated June 1, 1988 made by Borrower in favor of Lender (the "Mortgage") encumbering certain real estate legally described on Exhibit A attacher, hereto and made a part hereof (the "Premises"), which Mortgage was recorded with the Office of the Recorder of Deeds of Cook Courcy, Illinois on June 16, 1988, as Document No. 88-263462. (The Note Mortgage and any other documents evidencing or securing the Loan collectively are referred to herein as the "Loan Documents.
- Borrower and Lender desire to reduce the interest rate of the C. Loan.

NOW, THEREFORE. in consideration of the sum of \$10.00 in hand paid by Borrower to Lender, the mutual promises contained in this Agreement, and other valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, Lender and Borrower hereby agree of follows:

- 1. Defined Terms. All capitalized terms used herein and not otherwise defined shall have the same meanings ascribed to them in the Note or Mortgage.
- 2. Reduced Interest Rate. The rate of interest payable under the Loan is hereby reduced from ning percent (9%) to 7.09%. All references to the nine percent (9%) interest rate payable under the Note, Mortgage or any other Loan Documents are hereby deleted and the new interest rate of 7.09% is substituted in place thereof, effective as of March 1, 1992.

The Note, Mortgage and all other Loan Doguments, as expressly modified and amended by this Agreement, shar? Continue in full force and effect, and the Loan Documents, as thus modified and amended, are hereby ratified, confirmed and approved.
