- Due on Sale Provisions. In the event of any sale of the premises securing the subject debt whether by contract sale, direct transfer of title, leage in excess of one year with an option to purchase, lease in excess of five years with or without an option to purchase, lease in excess of five years with or without an option to purchase, assignment of beneficial interest in a land trust, or other such transfer of interest, the entire unpaid principal balance plus interest shall become due and payable.
