UNIFORM COVENANTS, Borrower and Lender covenant and agree as follows.

1. Payment of Principal and Interest; Prepayment and Late Charges, Porrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. paragraph 18, by causing the action or proceeding to be dismissed with a ruling that, in Lender's good faith determination, precludes forfeiture of the Borrower's interest in the Property or other material impairment of the lien created by this Security Instrument or Lender's security interest. 16. Borrower's Copy. Borrower shall be given one conformed copy of the Note and of this Security Instrument.

47.
