RELEASE OF CLAIM FOR LIEN

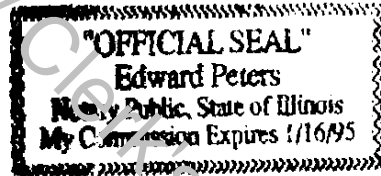
