SHORT FORM POWER OF ATTORNEY

FOR PROPERTY

POWER OF ATTORNEY made this 20th day of March, 1992.

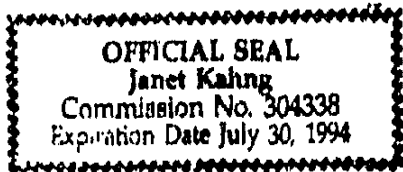
