Agreement made March 26, 1992 by and among Richard C. & Patricia A. Metz (Mortgagor),  
1st Federal Savings and Loan (Lender) and NBD Bank of Arlington Heights (Mortgagee),  
Association of Rockford

The parties recite and declare that:

A. Mortgagor has extended credit to Mortgagor and Mortgagee is the owner and holder of a certain Mortgage to secure debts, obligations and liabilities of Mortgagor owed to it which Mortgage is dated May 25th, 1990 and recorded June 7, 1990 in the Office of the County Recorder of Winnebago County, Illinois on Microfilm No. 20017990 and Document No. 90269239 and covering the premises described upon Exhibit A attached hereto (Mortgagor's Mortgage).

B. Lender is the owner and holder of a note totaling Sixty two thousand five hundred (\$62,500.00) secured by a mortgage from Mortgagor (Lender's Mortgage) on and covering the premises above described.

C. To induce Lender to make such loan it is necessary that the Mortgagor's Mortgage be subordinate to the lien of the Lender's Mortgage.

D. Mortgagor and Mortgagee have previously represented to Lender that Mortgagor would subordinate the lien of Mortgagor's Mortgage to the lien of Lender's Mortgage, upon which representation Lender has relied in making its loan to Mortgagor.

For the reasons set forth above, and in consideration of the mutual covenants and promises of the parties hereto, the parties covenant and agree the recitals set forth above are a part of this agreement and further agree as follows:

1. SUBORDINATION. Mortgagor, Lender, covenants, consents and agrees with Lender that Mortgagor's Mortgage is and shall continue to be subject to and subordinate in lien to the lien of Lender's Mortgage.

2. BINDING EFFECT. This agreement shall be binding upon and their to the benefit of the respective heirs, legal representatives, successors and assigns of the parties hereto.




