SUBORDINATION AGREEMENT

THIS AGREEMENT made this 12th day of January, 1992
by and between West Suburban Neighborhood Preservation Agency as
the holder of a certain Trust Deed dated December 26, 1984
registered January 21, 1985 as Document 3415680 and Home Savings of
America, F.S.B., a Corporation organized and existing under the
laws of the State of Illinois (hereinafter referred to as "Home
Savings").

WHEREAS, Chicago Title and Trust Company is the Trustee under
certain Trust Deed dated December 26, 1984 and registered as
Document No. 3415680 evidencing indebtedness from John E. Hogan and
Mary M. Hogan, his wife, to the West Suburban Neighborhood
Preservation Agency; and

WHEREAS, Home Savings is about to make a mortgage loan to said
John E. Hogan and Mary M. Hogan, said mortgage to be secured by the
property commonly known as 1032 Ferdinand, Forest Park, Illinois;
and recorded as document # 12-1-1032; and

WHEREAS, the West Suburban Neighborhood Preservation Agency
has consented to the subordination of its interest in and to the
subject property to the interest of Home Savings.

NOW THEREFORE, pursuant to such agreement and in consideration
of the payment of the sum of \$10.00 and other good and valuable
consideration, the receipt and sufficiency of which are hereby
acknowledged, the parties mutually covenant and agree as follows:

1. The Lien of the West Suburban Neighborhood Preservation
Agency as evidenced by a certain Trust Deed dated December 26, 1984
and registered as Document No. 3415680 shall, upon the recording of
the trust deed (mortgage) in favor of Home Savings, be subordinate
and inferior to the interest of Home Savings, recorded as doc# 12-1-1032.

2. That the interest of the West Suburban Neighborhood
Preservation Agency created through the aforementioned Trust Deed
shall remain superior to all other subsequent Liens. The balance
of the terms of said instrument shall remain in full force and
effect.
