AN ORDINANCE ANNEXING CERTAIN TERRITORY  
ON THE WESTERN SIDE OF BATEMAN ROAD IN  
COOK COUNTY TO THE VILLAGE OF  
BARRINGTON HILLS, LAKE, COOK, KANE AND  
MC HENRY COUNTIES, ILLINOIS

WHEREAS, a written petition under oath by the owners of record of the land hereinafter described has been filed with the Village Clerk of the Village of Barrington Hills; and

WHEREAS, the petition for annexation complies in all respects with Chapter 24, Section 7-1-1 et seq. of the Illinois Revised Statutes; and

WHEREAS, said land is not within the corporate limits of any municipality, but is contiguous to the Village of Barrington Hills; and

WHEREAS, the President and Board of Trustees of the Village of Barrington Hills find and believe it to be in the best interest of said Village that the said land and territory be annexed to the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington Hills, Cook, Lake, McHenry and Kane Counties, Illinois, as a Home Rule municipality, as follows:

Section One: That all land and territory legally described as follows:

The West 150 feet of the West Half of the Northwest Quarter of Section 18, Township 42 North, Range 9 East of the Third Principal Meridian in Cook County, Illinois; also, the West 190 feet of the North Half of Government Lot 2 of the Southwest Quarter of Section 18, Township 42 North, Range 9 East of the Third Principal Meridian in Cook County, Illinois.

which land and territory is contiguous to the Village of Barrington Hills and is not within any other municipality but is in the unincorporated area of Cook County, and an accurate map of which land and territory is attached hereto and made a part hereof by this reference be, and the same is, annexed to the Village of Barrington Hills so that hereafter such land and territory shall be included within the boundary line and limits of said Village.

Section Two: The Village Clerk of the Village of Barrington Hills is hereby directed to record in the offices of the Recorder of Deeds of Cook county, Illinois and to file in the office of the county clerk of Cook County, Illinois, a certified copy of this ordinance, together with a plat of annexation for the territory annexed.

Section Three: This ordinance shall be in full force and effect from and after its passage and approval as provided by law.
