

- The registered office must include a street or road address, a post office box number alone is not acceptable 2.
- 3. A corporation cannot set as its own registered agent.
- If the registered office is changed from one county to another, then the corporation must file with the records 4. of deeds of the new county a cellified copy of the articles of incorporation and a certified copy of the statemen of change of registered office. Such certified copies may be obtained ONLY from the Secretary of State.
