2. On December 10, 1991, the owner owned the following described land in the County of Cook, State of Illinois, to wit:

All of the land, property and space below, at and above the surface of the earth in Marshall Field and Company's and Chicago and Northwestern Railway Company's Resubdivision of Blocks 5 and 6 in the Original Town of Chicago, all in the South 1/2 of Section 9, Township 39 North, Range 14, East of the Third Principal Meridian, except that part thereof described as follows: ("A") Lot 10 in said resubdivision; and ("B") the south 24 1/2 foot of Lot 6 in said resubdivision; and ("C") the south 28 1/2 feet of lot 6 "A" in said resubdivision, all in Cook County, Illinois.

PTA NO. 11-01-905-001,002 (the "Premises") and Conversion was the owner's contractor for the improvement thereof.

3. On November 12, 1991, the contractor made a contract with claimant to furnish, deliver and install floor tile and wall tile for the sum of \$8,465.00 for and in the improvement of the Premises, and that on December 10, 1991, claimant completed thereunder all required by the contract to be done.
