

THE ACCEPTANCE OF THIS CONVEYANCE BY THE GRANTESS SHALL BE DEEMED AN AGREEMENT WITHIN THE CONTEMPLATION OF THE CONDOMINIUM PROPERTY ACT OF THE STATE OF ILLINOIS TO A SHIFTING OF THE COMMON ELEMENTS PURSUANT TO SAID DECLARATION, WHICH IS HEREBY INCORPORATED HEREIN BY REFERENCE THERETO. AND TO ALL THE TERMS OF EACH AMENDED DECLARATION RECORDED FURSUANT THERETO.
