- 4. FUTURE ADVANCES AND EXPENSES. This Mortgage secures a propagment of all advances that Lender may extend to Borrower or Grantor under the promissory notes and other agreements evidencing the revolving credit toans described in paragraph 2. - 10. USE AND MAINTENANCE Of PFOPER IN Gran or shall across any experience and make any experience ded to maintain the Property in good condition. Grantor shall not commit or permit any waste to be committed with expect to the Property. Grantor shall use the Property solely in compliance with applicable law and insurance policies. Grantor shall not make any alterations, additions or improvements to the Property without Lender's prior written consent.
