THEREFORE, it is hereby agreed that, as of the date of this Agreement, the unpaid balance of said indebtedness is **Eight Hundred Thirty Thousand and no/100** Dollars (\$830,000.00 ),

all of which the undersigned promises to pay with interest at **9.75** % per annum until paid, and that the

same shall be payable **SEVEN THOUSAND EIGHT HUNDRED SEVENTY TWO AND 69/100** Dollars (\$ 7,872.69 ),

per month beginning on the **First** day of **June** 19 **92**, to be applied first to interest, and balance to principal, plus a sum estimated to be sufficient to discharge taxes and insurance obligations (which estimated sum may be adjusted as necessary) and that in all other respects said mortgage contract shall remain in full force and effect.




