SUBCONTRACTOR'S CLAIM FOR LIEN

property; on or about May 30, 1990, original contractor enterd into a written contract with claimant to furnish all labor, material, tools and equipment and to perform all work necessary to complete excavation and earth moving work in the improvement of the above-described real property.

4. The balance now due and owing to claimant from the subcontractor for work performed to improve the above-described real property, after allowing all credits, is \$32,799.00, together with interest and attorneys' fees as provided by statute.
