PARTIAL RELEASE DEED

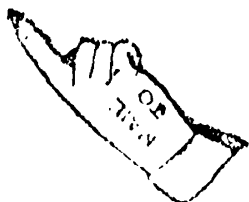

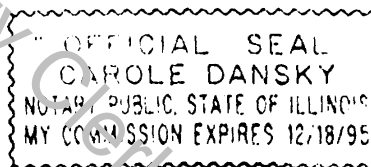
