

SUBORDINATION OF LIEN

WHEREAS, David A. Mark and Jean E. D'Amico

as mortgagee that the note owned by said Baxter Credit Union and of the mortgage securing same shall be and remain at all times a second lien upon the premises thereby conveyed subject to the lien of the mortgage to said Great Northern Mortgage as aforesaid for all advances made or to be made on the notes secured by said last named mortgage and for all other purposes specified therein.

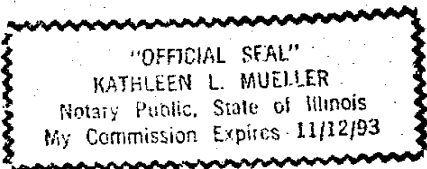
