MORTGAGE

THIS MORTGAGE, made as of this 23rd day of April, 1992, by First Chicago Trust Company of Illinois, not individually, but as Trustee under Trust Agreement dated April 21, 1992, and known as Trust No. RV-V()640 (herein called the "First Party") to FIRST CHICAGO BANK OF RAVENSWOOD, an Illinois Banking corporation, (herein together with its successors and assigns, including each and every from time to time nolder of the Note hereinafter described called "Mortgagee").

WITNESSETH

WHEREAS, First Party is the owner and holder of fee simple title in and to all of the real estate described in Exhibit "A" attached hereto and by this reference made a part hereof which real estate forms a portion of Premises hereinafter described;

WHEREAS, John R. Wilson and Kathryn S. Wilson, his wife; (herein collectively called "Maker") have concurrently herewith, executed and delivered the Note (herein called the "Note") bearing even date herewith, payable to the order of Mortgagee in the original principal sum of TWO HUNDRED FORTY THREE THOUSAND and NO/100 Dollars (\$243,000.00), bearing interest at the rate specified therein, with a maturity date of May 1, 2022, subject to certain call options in favor of Mortgagee.

WHEREAS, the (i) indebtedness evidenced by the Note including the principal thereof and interest and premiums, if any thereon, and all extensions or renewals thereof, in whole or in part, (11) any further advances made by holder of the Note to First Party for any purpose set forth herein, or in any document executed in connection therewith, at any time, before the release and cancellation of this Mortgage, and (iii) all other sums which may be at any time due or owing or required to be paid as herein provided, all of which are herein sometimes called the "Indebtedness Hereby Secured", provided however, that the Indebtedness Hereby Secured shall not exceed a sum equal to two times the original principal amount of the Note.

NOW THEREFORE, to secure the payment of the principal of and interest on the Note according to its tenor and effect, and to secure the payment of all other Indebtedness Hereby Secured, and the performance and observance of all the covenants, agreements and provisions herein and in the Note contained, and in consideration

of the premises and of the sum of \$10.00 paid to the First Party, and for other valuable consideration, the receipt and sufficiency whereof is hereby acknowledged by the First Party, the First Party DOES HEREBY GRANT, REMISE, MORTGAGE, RELEASE, ALIEN AND CONVEY unto Mortgagee, its successors and assigns forever, the real estate described in Exhibit "A" attached hereto and by this reference made a part hereof (herein, together with the property mentioned in the next succeeding paragraphs hereto, called the "Premises");

TOGFINDR with all right, title and interest of First Party including any after-acquired title or reversion, in and to the rights of ways, streets, avenues and alleys adjoining the Premises;

TOGETHER with all regular and singular the tenements, hereditaments, easyments, appurtenances, passages, waters, water courses, riparian rights, other rights, liberties and privileges thereof or in any way now or hereafter appertaining, including any other claim at law or in equity as well as any after-acquired title, franchise or license, and the reversions and remainders thereof;

TOGETHER with all rents, income, receipts, revenues, issues, proceeds and profits accruing and to accrue from the Premises;

TOGETHER with all buildings and improvements of every kind and description now or hereafter erected or placed thereon and all materials intended for construction, reconstruction, alteration and repairs of such improvements now or herselter erected thereon, all of which materials shall be deemed to be included within the Premises, and all fixtures and articles of personal property now or hereafter owned by First Party and attached to or contained in and used in connection with the Premises and/or the operation and convenience of any building or buildings and improvements located including, but without limitation, all furniture, furnishings, equipment, apparatus, machinery, motors, elevators, plumbing, electrical, heating, lighting, and all ventilating, refrigerating, incineration, air conditioning and sprinkler equipment, systems, fixtures and conduits and all ranswals or replacements thereof or articles in substitution therefor, in all cases whether or not the same are or shall be attached to said building or buildings in any manner, it being mutually agreed that all of the Premises shall, so far as permitted by law, be deemed to be fixtures, a part of the realty and security for the Indebtedness Notwithstanding the agreement and declaration Hereby Secured. hereinabove expressed that certain articles of property form a part of the realty covered by this Mortgage and be appropriated to its use and deemed to be realty, to the extent that such agreement and declaration may be effective and that any of said articles may constitute goods (as said term is used in the Uniform Commercial Code) this instrument shall constitute a security agreement,

creating a security interest in such goods, as collateral in Mortgagee as a secured party, all in accordance with said Uniform Commercial Code as more particularly set forth in Paragraph 17 hereof.

TOGETHER with all right, title, estate and interest of the First Party in and to the Premises, estate, property, improvements, furniture, furnishings, apparatus and fixtures hereby conveyed, assigned, pledged and hypothecated, or intended so to be, and all right to retain possession of the Premises after event of default in payment, or breach of any covenant herein contained; and

TOGETHER with all awards and other compensation heretofore or hereafter to be made to the present and all subsequent owners of the Premises for any taking by eminent domain, either permanent or temporary, of all or any part of the Premises or any easement or appurtenance thereof, including severance and consequential damage and change in grade of streets, which said awards and compensation are hereby assigned to Mortgagee pursuant to the provisions hereof, and First Party, in the evert of the occurrence and continuation of an Event of Default hereunder, hereby appoints Mortgages its attorney-in-fact, coupled with an interest, and authorizes, directs and empowers such attorney, at the option of the attorney, on behalf of First Party, or the successors or assigns of First Party, to adjust or compromise the claim for any award and to collect and receive the proceeds thereof, to give proper receipts and acquittances therefor, and, after deducting expenses of collection, to apply the net proceeds as a credit upon any portion, as selected by Mortgagee, of the Indebtedness Hereby Secured, all subject to the provisions of Paragraph 10 hereof.

TO HAVE AND TO HOLD the Premises, with the appurtenances, and fixtures, unto the Mortgagee, its successors and assigns, forever, for the purposes and upon the uses and purposes herein set forth together with all right to possession of the Premises upon the occurrence of any Event of Default as hereinafter defined; the First Party hereby RELEASING and WAIVING all rights under and by virtue of the homestead exemption laws of the State of Illinois.

PROVIDED, NEVERTHELESS, that if the First Party shall pay when due the Indebtedness Hereby Secured and shall duly and timely perform and observe all of the terms, provisions, covenants and agreements herein provided to be performed and observed by the First Party, then this Mortgage and the estate, right and interest of the Mortgagee in the Premises shall cease and become void and of no effect, otherwise to remain in full force and effect.

THE FIRST PARTY COVENANTS AND AGREES AS FOLLOWS:

- 1. Payment of Indebtedness: The First Party shall pay when due (a) the principal of and interest and premium, if any, on the indebtedness evidenced by the Note and (b) all other Indebtedness Hereby Secured; and the First Party shall duly and punctually perform and observe all of the terms, provisions, conditions, covenants and agreements on the First Party's part to be performed or observed as provided herein and in the Note; and this Mortgage shall secure such payment, performance and observance.
- Maintenance, Repair, Restoration, Liens, Etc.: The First Party shall (a) promptly repair, restore or rebuild any building or improvement now or hereafter on the Premises which may become damaged or be destroyed whether or not proceeds of insurance are available or sufficient for the purposes; (b) keep the Premises in good condition and repair without waste, and free from mechanic's, materialmen's or like lieng or claims or other liens or claims for lien; (c) pay, when due, iny indebtedness which may be secured by a lien or charge of the Premises superior or inferior to the lien hereof and, upon request, exhibit to the Mortgagee satisfactory evidence of the discharge or such liens, (d) complete the construction of any improvements within a reasonable time, now or at any time in the process of repair or erection upon the Premises; (e) comply with all requirements of law, municipal ordinances or restrictions and covenants of record with respect to the Premises and the use thereof; (f) make or permit no material alterations in the Premise except as required by law or ordinance without the prior written consent of the Mortgagee; (g) suffer or permit no change in the general nature of the occupancy of the Premises; (h) initiate or acquiesce in no zoning reclassification with respect to the Premises; and (i) suffer or permit no unlawful use of, or nuisance to exist upon the Premises.
- 3. Other Liens: The First Party shall not create or suffer or permit any mortgage, lien, charge or encumbrance to attach to the Premises, whether such lien, charge or encumbrance is inferior or superior to the lien of this Mortgage, excepting only the lien of real estate taxes and assessments not due or delinquent.
- 4. Taxes: The First Party shall pay before any penalty attaches, all general and special taxes, assessments, water charges, sewer charges, and other fees, taxes, charges and assessments of every kind and nature whatsoever (all herein generally called "Taxes"), whether or not assessed against the First Party, if applicable to the Premiser or any obligation or agreement secured hereby; and First Party shall, upon written request furnish to the Mortgagee duplicate receipts therefor. The First Party shall pay in full under protest in the manner provided by statute, any Taxes

which the First Party may desire to contest; provided, however, that if deferment of payment of any such Taxes is required to conduct any contest or review, the First Party shall deposit with the Mortgagee the full amount thereof, together with an amount equal to the estimated interest and penalties thereon during the period of contest, and in any event, shall pay such Taxes notwithstanding such contest, if in the opinion of the Mortgagee the Premises shall be in jeopardy or in danger of being forfeited or foreclosed; and if the First Party shall not pay the same when required to do so, the Mortgagee may do so and may apply such deposit for the purpose. the event thar any law or court decree has the effect of deducting from the value of the land for the purpose of taxation any lien thereon, or imposing upon the Mortgagee the payment of the whole or any part of the Tracs or liens herein required to be paid by the First Party, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the interest of the Mortgagee in the remises, or the manner of collection of Taxes, so as to adversely affect this Mortgage or Indebtedness Hereby Secured or the Mortgagee, then, and in any such event and in the further event that such taxes are not paid, the First Party, upon demand by the Mortgagee, shall pay such Taxes, or reimburse the Mortgagee therefor on demand, unless such payment or reimbursement by First Party is unlawful in which event the Indebtedness Hereby Secured shall be due and payable within ten (10) days after written demand by Mortgagee to First Party. Nothing in this Paragraph 4 contained shall require the First Party to pay any income, franchise or excise tax imposed upon the Mortgagee, excepting only such which may be levied against such income expressly as and for a specific substitute for Taxes on the Premises, and then only in an amount computed as if the Mortgagee derived no income from any source other than its interest hereunder.

- 5. <u>Insurance Coverage</u>: The First Party will insure or cause to be insured and keep or cause to be kept insured all of the buildings and improvements now or hereafter constructed or erected upon the Premises and each and every part and parcel trareof, against such periods and hazards as the Mortgagee may from time to time require, and in any event including (but not by way of limitation):
 - (a) Insurance against loss by fire, risks covered by the so-called extended coverage endorsement, and other risks as the Mortgagee may reasonably require, in amounts equal to the full replacement value of the Premises;
 - (b) Public liability insurance against bodily injury and property damage with such limits as the Mortgagee may require;

- (c) Steam boiler, machinery, rent loss, liquor liability (dram shop), if applicable, and other insurance of the types and in amounts as the Mortgagee may require but in any event not less than customarily carried by persons owning or operating like properties.
- 6. Insurance Policies: All policies of insurance to be maintained and provided as required by Paragraph 5 hereof shall be in form and with companies and amounts reasonably satisfactory to the Mortgagee and all policies of casualty insurance shall have attached thereto mortgagee clauses or endorsements in favor of and with loss payable to and in form satisfactory to the Mortgagee requiring at least thirty (30) days notice of any cancellation to be given to Mortgagee. The First Party will deliver all policies (or certificates evidencing said policies), including additional and renewal policies to the Mortgagee unless such policies are delivered to the holder of the role described in Paragraph 3 hereof and, in case of insurance policies not less than ten (10) days prior to the respective dates of expiration.
- Deposits for Tax and Insurance Deposits: For the purpose of providing funds with which to ray the general taxes and special assessments levied against the said premises, First Party shall make monthly deposits with the holder of the Note on the first day of each month, in an amount estimated by the holder of the Note to be equal to 1/12th of the general real egrate taxes and special assessments last levied against the same Fremises, and equal to 1/12th of the bills last received for premiums in insurance covering the Premises. Such deposit shall be computed and made by the First Party so that the holder of the Note shall have in its possession one month prior to the due date, the amount necessary to pay the said real estate taxes and to pay premiums for renewal or No interest shall be replacement of expiring insurance policies. allowed on account of any deposit or deposits made hereunder and said deposits need not be kept separate and apart. If, at the time tax bills are issued for real estate taxes or special assessments for any year, and bills for renewal or replacement of insurance policies are received, the amount theretofore so deposited shall be less than the amount of such taxes and assessments for that year, less than the amount needed to renew or replace expiring insurance policies, First Party agrees to deposit with holder of the Note the difference between the amount theretofore deposited hereunder and the amount required to effect payment of general real estate taxes and special assessments for such year, or required to effect payment for the renewal or replacement of expired insurance policies, such deposit to be made within ten (10) days prior to the penalty date of such tax bills, and within ten (10) days prior to the due date for payment of renewal or replacement of insurance

premiums. In the event of a default in any of the provisions contained in this Mortgage, the holder of the Note may, at its option, without being required so to do, apply any tax or insurance deposits on hand on any of the Indebtedness Hereby Secured, in such order and manner as the holder of the Note may elect. When the Indebtedness Hereby Secured has been fully paid, than any remaining tax or insurance deposits shall be paid to the First Party. All tax insurance deposits are hereby pledged as additional security for the Indebtedness Hereby Secured, and shall be held in trust, without interest or income, to be irrevocably applied for the purposes for which it is made, as herein provided, and shall not be subject to the direction or control of the First Party.

- 8. Proceeds of Insurance: The First Party will give the Mortgagee prompt notice of any damage to or destruction of the Premises and permit mortgagee or its agents to inspect from time to time the damage or destruction, subject to and in accordance with the provisions of the Agreement, and:
 - (a) In case of icss covered by policies of insurance, the Mortgagee (or, after entry of decree of foreclosure, the purchaser at the foreclosure sale or decree creditor, as the case may be) is hereby authorized at its option either (i) to settle and adjust to any claim under such policies without the consent of the First Party, or allow the First Party to agree with the insurance company or companies on the amount to be paid upon the loss; and provided that in any case the Mortgagee shall, and is hereby authorized to, collect and receipt for any such insurance proceeds; and the expenses incurred by the Mortgagee in the adjustment and collection of insurance proceeds shall be so much additional Indebtedness Hereby Secured, and shall be reimbursed to the Mortgagee upon demand.
 - (b) In the event of any insured damage to or destruction of the Premises or any part thereof (herein called an "Insurance Casualty"), and if, in the reasonable judgment of the Mortgagee, the Premises can be restored to an economic unit not less valuable than the same was prior to the Insured Casualty and adequately securing the outstanding balance of the Indebtedness Hereby Secured, then, if no Event of Default, as hereinafter defined, shall have occurred and be then continuing, the proceeds of insurance shall be applied to reimburse the First Party for the cost of restoring, repairing, replacing or rebuilding the Premises or part thereof, as provided for in Paragraph 9 hereof; and the First Party hereby covenants and agrees forthwith to commence and diligently to proceed with such restoring, repairing, replacing or rebuilding; provided, always, that the First

Party shall pay all costs of such restoring, repairing, replacing or rebuilding in excess of the net proceeds of insurance made available pursuant to the terms hereof.

- (c) Except as provided in Subsection (b) of this Faragraph 8, the Mortgagee may apply the proceeds of insurance consequent upon any Insured Casualty upon the Indebtedness Hereby Secured, in such order or manner as the Mortgagee may elect.
- (d) In the event that proceeds of insurance, if any, shall be made available to the First Party for the restoring, repairing replacing or rebuilding of the Premises, the First Party hereby covenants to restore, repair, replace or rebuild the same, to be of at least equal value, and of substantially the same character as prior to such damage or destruction, all to be effected in accordance with plans and specifications to be first submitted to and approved by the Mortgagee.
- Disbursement of Insurance Proceeds: In the event the First Party is entitled to ranbursement out of insurance proceeds held by the Mortgagee, such proceeds shall be disbursed from time to time upon the Mortgagee being furnished with satisfactory evidence of the estimated cost of completion of the restoration, repair, replacement and rebuilding with funds (or assurances satisfactory to the Mortgagee that such funds are available) sufficient in addition to the proceeds of insurance, to complete the proposed restoration, repair, replacement and rebuilding and with such architect's certificates, waivers of lien contractor's sworn statements, title insurance endorsements, plats of survey and other such evidences of cost, payment and performance at the Mortgagee may reasonably require and approve; and the Mortgagee way, in any event, require that all plans and specifications for such restoration, repair, replacement and rebuilding be submitted to and approved by the Mortgagee prior to commencement of work. No payment rade prior to the final completion of the restoration, repair, replacement and rebuilding shall exceed ninety percent (90%) of the valua of the work performed from time to time; funds other than processis of insurance shall be disbursed prior to disbursement of such proceeds; and at all times the undisbursed balance of such proceeds remaining in the hands of the Mortgagee, together with funds deposited for that purpose or irrevocably committed to the satisfaction of the Mortgagee by or on behalf of the First Party for that purpose, shall be at least sufficient, in the reasonable judgment of the Mortgagee, to pay for the cost of completion of the restoration, repair, replacement or rebuilding, free and clear of all liens or claims for Any surplus which may remain out of insurance proceeds held by the Mortgagee after payment of such costs of restoration, repair, replacement or rebuilding or costs or fees incurred in obtaining

such proceeds shall, at the option of the Mortgagee, be applied on account of the Indebtedness Hereby Secured. No interest shall be allowed to the First Party on account of any proceeds of insurance or other funds held in the hands of the Mortgagee.

- The First Party hereby assigns, transfers Condemnation: and sets over unto the Mortgagee the entire proceeds of any award or claim for damages for any of the Premises taken or damaged under the power of eminent domain or by condemnation including any payments made in lieu of and/or in settlement of a claim or threat The Mortgagee may elect to apply the proceeds of of condemnation. the award upon or in reduction of the Indebtedness Hereby Secured then most remotely to be paid, whether due or not, or require the First Party to restore or rebuild the Premises, in which event, the proceeds shall be held by the Mortgages and used to reimburse the First Party for the cost of such rebuilding or restoring. the reasonable judgment of the Mortgagee, the Premises can be restored to an economic unit not less valuable then the same was prior to the condemnation and adequately securing the outstanding balance of the Indebtedness Mereby Secured, the award shall be used to reimburse the First Party for the cost of restoration and rebuilding; provided always, that no Event of Default has occurred and is then continuing. If the First Party is required or permitted to rebuild or restore the Premises as aforesaid, such rebuilding or restoration shall be effected solely in accordance with plans and specifications previously submitted to and approved Mortgagee, and proceeds of the award shall be paid out in the same manner as is provided in Paragraph 9 hereof for the payment of insurance proceeds toward the cost of rebuilding or restoration. If the amount of such award is insufficient to cover the cost of rebuilding or restoration, the First Party shall pay such costs in excess of the award, before being entitled to reinfursement out of Any surplus which may remain out of the award after the award. payment of such costs of rebuilding or restoration of costs or fees incurred in obtaining such award shall, at the option of the Mortgagee, be applied on account of the Indebtedness Hereby Scaured. No interest shall be allowed to First Party on account of any award held by Mortgagee.
- 11. Tax Stamp: If, by the laws of the United States of America, or of any state or municipality having jurisdiction over the First Party or the Premises, any tax becomes due in respect of the issuance of the Note or this Mortgage, the First Party shall pay such tax in the manner required by law.
- 12. <u>Prepayment Privilege</u>: The First Party shall have the privilege of making payments on the principal of the Note in accordance with the terms of the Note.

- Effect of Extension of Time and Amendments of Junior Liens and Other: If the payment of the Indebtedness Hereby Secured, or any part thereof, be extended or varied, or if any part of the security therefor be released, all persons now or at any time hereafter liable therefor, or interested in the Premises, shall be held to assent to such extension, variation or release, and their liability, and the lien and all provisions hereof, shall continue in full force and effect; the right of recourse against all such persons being expressly reserved by the Mortgagee, notwithstanding any such extension, variation or release. Any person, firm or corporation taking a junior mortgage or other lien, upon the Premises or any interest therein, shall take the said lien subject to the rights of the Mortgagee to amend, modify and supplement this Mortgage, the Note and the Assignments herein referred to, and to extend the maturity of the Indebtedness Hereby Secured, in each and every case without obtaining the consent of the holder of such junior lien and without the lien of this Mortgage losing its priority over the rights of any such junior liens.
- 14. Mortgagee's Performance of First Party's Obligations: In case of an Event of Default herein, the Mortgagee, either before or after acceleration of the Intebtedness Hereby Secured or the foreclosure of the lien hereof and during the period of redemption, if any, may but shall not be required to, make any payment or perform any act herein required of the First Party (whether or not the First Party is personally liable therefor) in any form and manner deemed expedient to the Mortgages; and the Mortgages may, but shall not be required to, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting the Premises or contest any tax or assessment, and may, but shall not be required to, complete construction, furnishing and equipping of the improvements upon the Premises and rent, operate and manage the Premises and such improvements and pay operating dosts and expenses, including management fees and insurance premiume of every kind and nature in connection therewith, so that the Premises and improvements shall be operational and usable for their intended purposes. All monies paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorney's fees and other monies advanced by the Mortgagee to the Premises and the lien hereof, or to complete construction, furnishing and equipping or to rent, operate and manage the Premises and such improvements or to pay any such operating costs and expenses thereof or to keep the Premises and improvements operational and usable for its intended purpose, shall be so much additional Indebtedness Hereby Secured, whether or not they exceed the face amount of the Note, and shall become immediately due and payable without notice and with interest thereon

at the Default Rate specified in the Note (herein called the "Default Rate"). Inaction of the Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default on the part of the First Party. The Mortgagee in making any payment hereby authorized (a) relating to taxes and assessments, may do so according to any bill, statement or estimate, without inquiry into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof; (b) for the purchase, discharge, compromise or settlement of any other prior lien, may do so without inquiry as to the validity or amount of any claim for lien which may and (c) in connection with the completion of be asserted; construction, furnishing or equipping of the improvements of the Premises or the rental, operation or management of the Premises or the payment of operating costs and expenses thereof, Mortgagee may do so in such amounts and to such persons as Mortgagee may deem appropriate and may enter into such contracts therefor as Mortgagee may deem appropriate or may perform the same itself.

- 15. <u>Inspection of Fremises and Records</u>: The Mortgagee shall have the right to inspect the Premises and all books, records and documents relating thereto at all reasonable times, and access thereto shall be permitted for that purpose.
- Financial Statements: First Party covenants and agrees while any Indebtedness Hereby Secured is outstanding, to furnish to the holder of the Note within ninety (90) days at the end of each fiscal year of its operation, an annual financial statement showing the operation of the Premises and of First Party's beneficiary, said financial statements being prepared by an independent certified public accountant, if required by Mortgages. The financial statements required under the provisions of this paragraph shall include the financial data relevant to the operation and ownership of the real estate and, in the event the improvements thereof are operated by a lessee, statements required shall include an audit of the operations of the lessee, which shall also be provided within ninety days of the end of the fiscal year of the lessee Each of such financial statements shall be comprehensive and reclect, in addition to other data, the following: gross income and source, real estate taxes, insurance, operating expenses in reasonable detail, depreciation, deduction for federal income tax purposes, federal income taxes and net income. Within thirty (30) days of filing, First Party shall furnish to the holder of the Note copies of federal and state income tax returns filed on behalf of each beneficiary.
- 17. <u>Uniform Commercial Code</u>: This Mortgage constitutes a Security Agreement under the Uniform Commercial Code of the State of Illinois (herein called the "Code") with respect to any part of the Premises which may or might now or hereafter be or be deemed to

be personal property, fixtures or property other than real estate owned by the First Party or any beneficiary thereof (all for the purposes of this Paragraph 17 called "Collateral"); all of the terms, provisions, conditions and agreements contained in this Mortgage pertain and apply to the Collateral as fully and to the same extent as to any other property comprising the Premises; and the following provisions of this paragraph 17 shall not limit the generality or applicability of any other provision of this Mortgage but shall be in addition thereto;

- (2) The First Party (being the Debtor as that term is used in the Code) is and will be the true and lawful owner of the Collatoral, subject to no liens, charges or encumbrances other than the lien hereof.
- (b) The Collateral is to be used by the First Party solely for business purposes, being installed upon the Premises for First Party's own use or as the equipment and furnishings furnished by First Party, as landlord, to tenants of the Premises.
- (c) The Collateral will be kept at the real estate comprised within the Premises and will not be removed therefrom other than in the ordinary course of business without the consent of the Mortyagee (being the Secured Party as the term is used in the Code) or any other person and the Collateral may be affixed to such real estate but will not be affixed to any other real estate.
- (d) The only persons having any interest in the collateral are the First Party and its beneficiaries, the Mortgagee, permitted tenants and users thereon.

- (c) If the First Party is a partnership or joint venture, or if any beneficiary of a trustee mortgagor is a partnership or joint venture, then if any general partner or joint venturer in such partnership or joint venture shall create, effect or consent to or shall suffer or permit any sale, assignment, transfer, lien, pledge, mortgage, security interest or other encumbrance or alienation of all or any part of the partnership interest or joint venture interest, as the case may be, of such partner or joint venturer;

Such appointment may be made either before or after sale, without regard to solvency or insolvency of the First Party at the time of application for such receiver, and without regard to the then value of the Premises or whether the same shall be then occupied as a homestead or not; and the Mortgagee hereunder or any holder of the Note or any employee or agent thereof may be appointed as such receiver of mortgages in Such receiver or mortgagee in possession shall have, possession. the power to collect the rents, issues and profits of the Premises during the pendency of such foreclosure suit and, in case of a sale and deficiency, during the full statutory period of redemption, if any, whether there be a redemption or not, as well as during any further times when the First Party, except for the intervention of such receiver or mortgagee in possession, would be entitled to collection of such rents, issues and profits and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the Premises during the whole of said period. Section 9601 et. seq.) ("CERCLA"), as amended from time to time, and regulations promulgated thereunder; (c) asbestos; (d) polychlorinated biphenyls; (e) any substance and presence prohibited the Premises is bУ Governmental Requirements; and (f) any other substance which by any Governmental Requirement requires special

handling in its collection, storage, treatment or disposal.

- (ii) "Hazardous Materials Contamination" shall mean the contamination (whether presently existing or hereafter occurring) of the improvements, facilities, soil, ground water, air or other elements on, or of, the Premises by Hazardous Materials, or the contamination of the buildings, facilities, soil, ground water, air or other elements on, or of, any other property as a result of Hazardous Materials at any time (whether before or after the date of this Mortgage) emanating from the Premises.
- First Party hereby Firec Party's Warranties: represents and warrants that no Hazardous Materials are now located on the Premises and that neither First Party nor any other person has, ever caused or permitted or any Hazardous Materials to be placed, held, located or disposed of, on, under or at the Premises or any part thereof. No part of the Premises has ever been used, to the best of First Party's knowledge prior to the First Party's becoming the Owner of the Premises or will be used during First party's ownership of the premises as a manufacturing, storage or dump site for Hazardous Materials, nor is any part of the Premises affected by any Hazardous Materials Contamication. To the best of the First Party's knowledge and belief, no property adjoining the Promises has ever been used as a megafacturing, storage or dump site for Hazardous Materials nor is any other property adjoining the Premises affected by Mazardous Materials Contamination.
- First Party's Covenants: First Party agrees to (a) give notice to Mortgagee immediately upon the First Party acquiring knowledge of the presence of any Hazardous haterials on the Premises or of any Hazardous Materials Contamination with a full description thereof; (b) promptly comply with any Governmental Requirement requiring the removal, treatment or disposal of such Hazardous Materials or Hazardous Materials Contamination and provide Mortgagee with satisfactory evidence of such compliance; and (c) provide Mortgagee, within thirty (30) days after demand by the Mortgagee, with a bond, letter of credit or similar financial assurance evidencing to the satisfaction that the necessary funds Mortgagee's available to pay the cost of removing, treating or disposing Hazardous Materials or Hazardous Contamination and discharging any assessments which may be established on the Premises as a result thereof.

- Mortgagee (by its officers, Site Assessments: employees and agents) at any time and from time to time. either prior to or after the occurrence of an Event of Default, may contract for the services of persons (the "Site Reviewers") to perform environmental site assessments ("Site Assessments") on the Premises for the purpose of determining there exists on the Premises any environmental condition which could result in any liability, cost of expense to the owner or occupier of such Premises arising under any stace, federal or local law, rule or regulation relating to Hazaricus Materials. The Site Assessment may be performed at time or times, upon reasonable notice, and reasonable conditions established by First Party which do not impede the performance of the Site Assessment. The Site Reviewers are hereby authorized to enter upon the Premises for such purposes. The Site Reviewers are further authorized to perform both above and below ground testing for environmental damage or the presence of Hazardous Materials on the Premises and such other tests on the Premises as may be necessary to conduct the Site Assessent in the reasonable opinion of the Site Reviewers. First Party will supply to the Site Reviewers such historical and operational information regarding the Premises as may be reasonably requested by the Site Reviewers to facilitate the Site Assessment and will make available for meetings with the Site Reviewers appropriate personnel having knowledge of such matters. On request, Mortgagee shall make the results of such Site Assessment Jully available to First Party, which (prior to an Event of Derault may at its election participate under reasonable procedures in the direction of such Site Assessment and the description of tasks of the Site Reviewers. The cost of performing such Site Pasessment shall be paid by First Party upon demand of Mortgages and any such obligations shall constitute additional Indebindness Hereby Secured by this Mortgage.
- (e) Indemnification: Regardless of whether any Site Assessments are conducted hereunder, any Event of Delault shall have occurred and be continuing or any remedies in respect of the Premises are exercised by Mortgagee, First Party shall defend, indemnify and hold harmless Mortgagee from any and all liabilities (including strict liability), actions, demands, penalties, losses, costs or expenses (including, without limitation, reasonable attorney's fees and remedial costs), suits, costs of any settlement or judgment and claims of any and every kind whatsoever which may now or in the future (whether before or after the release of this Mortgage) be paid, incurred or suffered by or asserted against, Mortgagee by any person or entity of governmental agency for, with respect to, or as a direct or indirect result of, the

presence on or under, or the escape, seepage, leakage, spillage, discharge, emission, discharging or release from the Premises of any Hazardous Materials or Hazardous Materials Contamination or arise out of or result from the environmental condition of the Premises or the applicability of any Governmental Requirement relating to Hazardous Materials (including, without limitation, CERCLA or any so called federal, state or local "Superfund" or "Superlien" laws, statute, law, ordinance, code, rule, order or decree), regardlass of whether or not caused by or within the control of Mortgagee. The representations, covenants and warranties contained in this Section 26 shall survive the release of this Mortgage.

- Mortgagee's Right to Remove Hazardous Materials: Mortgagee shall have the right but not the obligation, without in any way limiting Mortgagee's other rights and remedies under this Mortgage, to enter onto the Premises or to take such other actions as it deems necessary or advisable to clean up, remove, resolve or minimize the impact of, or otherwise deal with, any Hazardous Materials or Hazardous Materials Contamination on the Premises following receipt of any notice from any person or entity asserting the existence of any Hazardous Materials or Hazardous Materials Contamination pertaining to the Premises, or any part thereof which, if true, could result in an order, suit, imposition of a lien on the Premises, or other action and/or which, in Mortgagee's sole opinion, could jeopardize Mortgagee's security under this Mortgage. All costs and expenses paid or incurred by Mortgagee in the exercise of any such rights shall be secured by this Mortgage and shall be payable by First Party upon demand.

Assignments: As further security for the Indebtedness Hereby Secured, the First Party and certain other parties have concurrently herewith executed and delivered, or may negative execute and deliver to the Mortgagee, Assignment of Leases and Rents, Security Agreements and other writings (herein collectively called the "Assignments") on the Premises and on other property. All the terms and conditions of the Assignments are hereby incorporated herein by reference as fully and with the same effect as if set forth herein at length. The First Party agrees that it will duly perform and observe or cause to be performed and observed all obligations accepted by it under the Assignments. - 30.
