ASSIGNMENT OF RENTS AND LEASES

WOW, THEREFORE, to secure the payment of (a) all sums becoming due under said Note according to the tenor and effect of said Note and any end all extensions renewals and substitutions therefore, (b) all other amounts becoming due from Assigner to Assignee under the Mortgage (said sins and other amounts being herein collectively called the "Indebtedness") and (c) the faithful performance by Assigner of all the covenants, conditions, stipulations and agreements in any of this Assignment of Renes and Indeses, in the Mortgage, or in any other instrument given in connection with the borrowing of the indebtedness and referred to in said Note or the Mortgage, and also in consideration of the sum of One Dollar (\$1.00) in mand paid, the receipt whereof which is hereby acknowledged, the Assigner does by these presents, GRANT, TRAISTR, and ASSIGN to the Assignee all the rents, issues and profits now due and which may hereafter become due, viether during or after the term of the Mortgage, under or by virtue of any lease, whether written or verbal, or any letting of or any agreement for the use or occupancy of any part of said Property, heretofore or hereafter made or agreed to, it being the intention of the undersigned to hereby establish an absolute transfer and assignment to Assignee of all such leases and agreements made or agreed to by either the undersigned or by the Assignee under the powers herein granted, and of all the avails thereof.

without limitation of any of the legal rights of Assignee as the absolute assignee of the lents, Issues, and profits of said Property, and by way of enumeration only, Assignor hereby irravocably covered, and agrees that in the event of any default by Assignor under the said Note of under the Mortgage above described, whether before or after the Note is declared to be immediately due, or whether before or after the institution of any legal proceedings to foreclose the lien of the Mortgage, or before or after any sale therein, forthwith upon demand of Assignee, Assignor will surrender to the Assignee and the Assignee shall be entitled to take actual possession of the said Property or of any part thereof, personally or by its agents or attorneys, as for condition broken, and in Assignee's discretion Assignee may, with or without force and with or without process of law, enter upon, take and maintain possession of all or any part of said Property tugether with all documents, books, records, papers, and accounts of Assignor relating thereto, and may exclude Assignor and Assignor's agents or servants wholly therefrom and may in Assignee's own name as Assignee under this Assignment hold, operate, manage, and control the said Property and conduct the business thereof, either personally or by Assignee's agents and may, at the expense of said Property from time to time either by purchase, repair, or construction make all necessary or proper repairs, renewals, replacements, useful alterations, additions,

betterments, and improvements to the said Property as to Assignee may seem judicious and may insure and reinsure the same, and may lease said Property in such parcels and for such times and on such terms as to the Assignee may seem fit, including leases for terms expiring beyond the maturity of the indebtedness secured by the Mortgage, and may cancel any lease or sublease for any cause or on any ground which would entitle Assignor to cancel the same, and may manage and operate the said Property and carry on the business thereof as Assignee shall deem best and do everything in or about the said Property that Assignor might do. In every such case Assignor hereby irrevocable authorizes and appoints Assignee, in the name, place and stead of Assignor, to collect and receive all earnings, revenues, rents, issues, profits and income of the said Property and any part thereof, and after deducting the expenses of conducting the business thereof and of all maintenance, repairs, renewals, replacements, alterations, additions, betterments, and improvements, and all payments which may be made for taxes, assessments, insurance and prior or proper charges on the said Property or any part thereof, including the just and reasonable compensation for the services of the Assignee for services rendered in connection with the operation, management and control of the said Property and the conduct of the business thereof, and such further sums as may be sufficient to indemnify Assignee against any liability, loss or damage on account of any matter, or thing done in good faith in pursuance of the rights and powers of Assignment hereunder, to apply any and all monies arising as aforesaid:

- (1) To payment of the interest from time to time accrued and unpaid on the said Note, or any renewals, extensions, or substitutions thereof:
- (2) To the payment of any and all other charges secured by or created under the said Mortgage;
- (3) To the payment of the principal of the said Note or any extensions, renewals, or substitutions thereof, from time to time remaining outstanding and unpaid:
- (4) to the payment of any other inductedness of Assignor to Assignee; and
- (5) To the payment of the balance, if any, after the payment in full of the terms hereinbefore referred to in 1), 2), 3), and 4) to Assignor.

Assignor nereby ratifles and confirms everything that Assignee may do under or by virtue of the foregoing.

Notwithstanding any other provisions hereof, or long as there shall exist no default by Assignor in the payment of the Indebtedness or in the performance of any obligation, covenant or agreement herein or in said Mortgage or other instrument contained, Assignor shall have the right to collect when, but not before due, all rents, issues and profits from said Property and to relain, use and enjoy the same.

Without limiting the generality of the foregoing, this Assignment covers all of the leases demising all or portions of the said Property.

Concerning said leases, Assignor hereby covenants and agrees to and with the Assignee that without the written consent of the Assignee first obtained, Assignor will not:

- (1) Cancel or terminate any lease for any reason whatsoever irrespective of huw such right of cancellation or termination is obtained, or permit the cancellation or termination thereof; or accept a surrender of any lease;
- (2) Reduce the rent provided for in any lease; or modify any lease in any way, either orally or in writing; or grant any concession in connection with any lease; either orally or in writing.
- [2] (3) Consent to any assignment of the interest of the tenant in any lease, or to any sub-lesting thereof;
 - (4) Accept any rent payable under any lease in advance of the time when the same is payable under the terms thereof; and any of the above acts, if done without the written consent of the Assignee, shall be nut; and void.
 - (5) Permit any lease to come before the Mortgage and shall subordinate all such leases to the liens of the Mortgage.

Concerning each such lease, Assignor further covenants, warrants and represents that, except as heretofore disclosed in writing to Assignee, there are no defaults not existing under any such leases nor is there any state of facts which with the giving of notice or lapse of time or both would constitute a default under any such lease and further that Assignor shall promptly notify Assignee of any notice received by Assignor claiming that a default has occurred under any such lease on the part of Assignor.

Any default on the part of Assignor hereunder shall constitute a default of Assignor under the Mortgage.

This Assignment shall be construed as a coverant running with the land, shall be assignable by Assigned and shall be binding upon and inure to the bonefit of each of the parties hereto and their respective executors, administrators, tegal representatives, successors and assigns.

The failure of Assignee or any of the Assignee's agents or attorneys, successors or assigns to make use of any of the terms, provisions, and conditions of this Assignment for any period of time, at any time or times, shall not be construed or deemed to be a waiver of any of Assignee's rights under the terms hereof, but Assignee or Assignee's agents or attorneys, successors, or assigns shall have full right, power and authority to enforce this Assignment or any of the terms, provisions or conditions hereof, and exercise the powers hereunder, at any time or time that shall be deemed fit.

In accepting this Assignment the Assignee herein does not assume nor shall it be under any obligation whatever to perform any of the covenants, undertakings or promises on the part of the Lessor to be performed under any lease which may be entered into concerning the said Property.

If the problemess shall be paid in full when or before due and Assignor shall keep observe and fully perform all the covenants, conditions, stipulations and agreements herein contained, then this assignment shall be null and voil and Assignor will, promptly upon Assignor's demand therefore, release and discharge this Assignment.

Any notice, demand, request or other communication desired to be given or required pursuant to the terms hereof shall be in writing rod shall be deemed given when personally served or on the second (2nd) day following deposit of the same in the United States Mail via registered or certified mail, return receipt requested, postage prepaid, addressed to the Assignor at the address set forth below or to the Assigner at the Bank's main office set forth above or to such other address as either the Assigner or the Assigner notifies the other party in writing.


