Note on or before the Maturity Date, then interest will be charged on the unpaid principal after the Maturity Date at a Default Rate of twenty-five percent (25%) per annum.

4. In all other respects, the terms and provisions of the Note and Mortgage shall remain inchanged and in full force and effect.
