

EXTENSION AGREEMENT

Whereas, NBD Elk Grove Bank, an Illinois Banking Corporation, ("Mortgagee") LOANED DONALD M. ROSE AND MARY E. EXTENSION OF THE LOAN

AND WHEREAS, the parties desire to restate the terms of said loan so that there shall be no misunderstanding of the matter;

THEREFORE, it is hereby agreed that, as of the date of this Agreement, the current unpaid balance of said indebtedness is TWO HUNDRED THOUSAND AND 00/100THS DOLLARS (\$200,000.00), all of which the undersigned promises to pay as follows:

Commencing on December 23, 1991 and continuing on the 23rd day of each month thereafter payments of interest only calculated at the rate of ten and three-quarters of one percent (10.75%) per annum for the remaining term of the loan. Final payment of all outstanding principal and accrued interest, if not sooner paid, shall be due and payable on November 23, 1992. THIS IS A BALLOON NOTE AND ON THE MATURITY DATE A SUBSTANTIAL PORTION OF THE PRINCIPAL AMOUNT OF THIS NOTE WILL REMAIN UNPAID BY THE MONTHLY PAYMENTS ABOVE REQUIRED.

AND WHEREAS, there are no other changes except for the changes set forth in this Agreement. The undersigned acknowledges that the Loan Agreement and Loan Documents are in full force and effect and are binding upon the Borrower according to their stated terms.

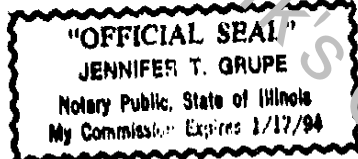

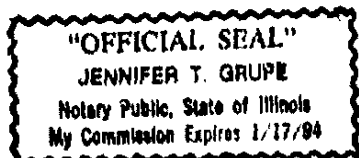

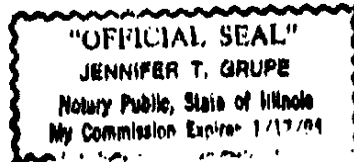
