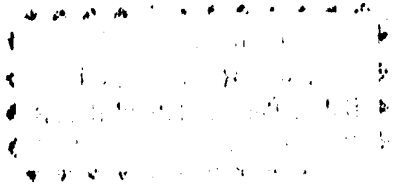

### LEGAL DESCRIPTION
