ASSIGNMENT OF MORTGAGE DEED OF TRUST

WHEREAS, ON MAY 25, 1990, GREAT AMERICAN FEDERAL SAVINGS AND
LOAN ASSOCIATION ("OLD GREAT AMERICAN") WAS CLOSED BY THE OFFICE
OF THE TRUST SUPERVISION (NOTS) PURSUANT TO SECTION 5(D) (2) (A) OF
THE HOME OWNERS' LOAN ACT OF 1933 ("HOLA") AS AMENDED BY
SECTION 301 OF THE FINANCIAL INSTITUTIONS REFORM, RECOVERY
AND ENFORCEMENT ACT OF 1989 ("FIRCA"), AND IMMEDIATELY APPOINTED
THE RESOLUTION TRUST CORPORATION AS RECEIVER OF OLD GREAT AMERICAN;

AND WHEREAS, ON MAY 25, 1990, THE FDIC BY ORDER NUMBERS 90-945
AND 90-946, APPOINTED THE RESOLUTION TRUST CORPORATION AS RECEIVER OF
NEW GREAT AMERICAN AND AS FEDERAL NATIONAL SAVINGS BANK, AND,
PURSUANT TO SECTION 301 OF THE HOME OWNERS' LOAN
ACT OF 1933, IMMEDIATELY APPOINTED THE RESOLUTION TRUST CORPORATION
CONSERVATOR OF THE NEW GREAT AMERICAN;

WHEREAS, THE RECEIVER TRANSFERRED THE ASSETS AND CERTAIN
LIABILITIES OF OLD GREAT AMERICAN TO NEW GREAT AMERICAN,
INCLUDING CERTAIN MORTGAGES OF TRUST WHICH ARE SUBJECT
TO THIS ASSIGNMENT PURSUANT TO A PURCHASE AND ASSUMPTION
AGREEMENT DATED MAY 25, 1990;

WHEREAS, ON SEPTEMBER 1, 1990, THE FDIC, BY ORDER NO. 90-1750
AND 90-1747, APPOINTED THE FDIC AS THE RECEIVER FOR NEW GREAT
AMERICAN AND
