NOTE AND MORTGAGE MODIFICATION AGREEMENT

On May 1, 1982, the undersigned Borrower ("Borrower") executed and delivered to Oak Park Trust & Savings Bank ("Bank"), now known as First Chicago Bank of Oak Park, a Promissory Note ("Note") in the principal amount of \$44,900.00 and to secure the payment of the Note executed and delivered to Bank a Mortgage ("Mortgage") on the real estate described on Exhibit A hereto, which Mortgage was, on May 18, 1982, recorded with the Recorder of Deeds of Cook County, Illinois as Document No. 20232470.

Borrower and Bank amend and modify the Note and Mortgage as follows:

1. Effective on April 1, 1992 the rate of interest on the principal balance due on the Note shall be the rate of 8.15 percent per annum. Beginning with April 1, 1992 monthly installments in amount of interest and principal thereon shall be paid in the amount of \$363.67.

2. Such monthly installments shall continue for five years after which one interest rate adjustment will be made based upon the U.S. Treasury Securities Index with a maturity of 5 years plus a margin of 2.75%; said adjustment shall be limited to a maximum interest rate change of 2.0% with any rate change reflected in the new payment, and shall continue until the entire indebtedness, if not sooner paid, final payment shall be due and payable on March 1, 2002.
