THIS INDENTURE, made the high had of April, 1992, between ANTONIOS FOLKAS AND PATRICIA FOLKAS, (herginafter referred to as "Mortgagors") and NATIONAL BANK of GREECE, S.A., Chicago Branch, a (herein referred to as "Mortgagoe") witnesseth:

THAT WHEREAS, Mortgagor has concurrently herewith executed a Mortgage Promissory Note bearing even date herewith in the principal sum of CME MILLION FORTY FIVE THOUSAND 00/100 (\$1,045,000.00) DOLLARS payable to Mortgagee and delivered, in and by which said Notes, Mortgagor promises to pay on or before April (1995, the said principal sum plus interest at the rate of TMO (2%) PERCENT above the Prime Commercial Rate of interest charged from time to time by the Bank and FOUR (4%) PERCENT above the Prime Commercial Rate of interest charged from time to time by the Bank after default or maturity with a minium interest rate of Eight and One Half (8.5%) Percent. The terms of said Note are incorporated by reference herein.

MOW, THEREFORE, this Mortgage is given to secure the payment of the said principal sum of money and said interest thereon and the performance of the covenants and agreements herein contained, as well as any and all renewals, modifications or extensions of the whole or any part of the indebtedness hereby secured however evidenced, with interest at such lawful rate as may be agreed upon. Any such renewal, modification, or extension or any change in the terms or rate of interest shall not impair in any manner the validity of or priority of this Mortgage, nor release the Mortgagor from personal liability for the indebtedness hereby secured. Therefore, the Mortgagor does by these presents, grant, remise, release, and convey unto the Mortgagee, its successors and assigns, the following described Real Estate situated, lying and being in the County of Lock and the State of Illinois, to-wit:

Which, with the property hereina ter described, is referred to herein as the "Premises."

TOGETHER with all improvement thereon and which may hereafter be erected or placed thereon, and all appurtenances, rights, royalties, mineral, all and gas rights, and easements thereunto belonging and the rents, issues and profits thereof, which are hereby recessly conveyed and assigned to the Mortgagee as additional security and as an equal and primary fund with the property herein conveyed for the repayment of the moneys secured by this Mortgage, and any and all appurtenances, fixtures and equipment in or that may at any time be placed in any building now or hereafter standing on said Premises.

It is mutually covenanted and agreed, by and between the parties hereto that, in addition to all other things which at law or by convention are regarded as fixture, and specifically but not by way of limitation all shades and awnings, screens and carpets, shrubbery, gas and electric fixtures, radiators, heaters, engines and machinery, boilers, ranges, elevators and motors, bathtuor, finks, water-closets, basina, pipes, faucets and other plumbing and heating fixtures, mirrors, mantels refrigerating plants, iceboxes, electric refrigerators, air conditioning apparatus, cooking apparatus and reportenances, and such other goods and chattels as may ever be furnished by a landlord in letting and open ting an unfurnished building, similar to said building now or hereafter standing on said Premises, whether or not the same are or shall be attached to said building by nails, screws, bolts, pipe connections, masonry, or in any ther monner whatsoever, which are now or hereafter to be used upon said described Premises shall be conclusively deemed to the "fixtures" and an accession to the freehold and a part of the reality, whether affixed or annexes or not, and conveyed by this Mortgage; and all the estate, right, title or interest on the said Mortgagor in and or said Premises, property, improvements, furniture, apparatus, furnishings and fixtures, are hereby expressly conveyed, assigned and pledged; and as to any of the property aforesaid, which does not so form a part and price of the Real Estate or does not constitute a "fixture" as such term is defined in the Uniform Commerical Code. This Mortgage is security interest in such property, which Mortgagor as Debtor hereby grants to the Mortgagor as Secured Party (as such terms are defined in the Uniform Commercial Code).

10 HAVE AND TO HOLD the above described Premises with the appurtenances and fixtures thereto appertaining or belonging unto the Mortgagee, its successors and assigns, forever, for the purposes herein set forth and for the security of the said Notes hereinbefore described, and interest thereon and free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the same Mortgagor does hereby expressly release and waive.

In addition, the Mortgagor covenants with the Mortgagee as follows:

- Mortgagor shall promptly pay when due without setoff, recoupment, or deduction, the principal
  of and interest on the indebtedness evidenced by the Notes, and late charges as provided in the Notes.
- 2. All payments received by Mortgagee under the Note and Paragraph 1 hereof shall be applied by Mortgagee first in payment of interest payable on the Notes, then to the principal of the Notes, including any amounts considered as added thereto under the terms hereof.
- Mortgagor shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the Premises which may become damaged or be destroyed; (2) keep said Premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the Premises superior to the lien hereof and exhibit satisfactory evidence of the discharge of such prior lien to Mortgagee; (4) complete within a reasonable time any building or buildings now or at any time in process of erection upon said Premises; (5) comply with all requirements of law or municipal ordinance, with respect to the Premises and

the use thereof; (6) make no m ter at the ations in stid Premises e cent as required by aw roundinance.

- 4. Mortgagor shall immediately pay when due all general taxes, and shall pay special taxes, special assessments, water charges, sever service charges, and other charges against the Premises when due, and shall furnish to Mortgagee duplicate receipts therefor within thirty (30) days after payment.
- 5. Mortgagor shall keep all buildings and improvements now or hereafter situated on said Premises insured against loss or damage by fire, lightning and such other risks and hazards as are insurable under the present and future forms of all-risk insurance policies, providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the Mortgagee, under insurance policies payable, in case of loss or damage, to Mortgagee, such rights to be evidenced by the standard mortgagee clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to Mortgagee, and in case of insurance about to expire, shall deliver renewal policies not less than ten (10) days prior to the respective dates of expiration. All policies of insurance shall contain a provision requiring that the coverage evidenced thereby shall not be terminated or materially modified without thirty (30) days prior written notice to the Mortgagee.
- In case of loss by fire or other casualty, the Mortgagee (or ofter entry of decree of foreclosure, purchaser at the sale, or the decree creditor, as the case may be) is hereby authorized either (i) to settle and adjust any claim under such insurance policies without consent of Mortgagor, or (ii) to allow Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss. In either case Mortgagee is avitor zed to collect and receipt for any such insurance money. If (i) Mortgagor is obligated to restore or replace the damaged or destroyed buildings or improvements under the terms of any lease or leases which are or may be prior to the lien of this Mortgage, and (ii) such damage or destruction does not result in cancellation or termination of such lease, and (iii) the insurers do not deny liability as to the insureds, such proceeds, after deducting there row any expenses incurred in the collection thereof, shall, subject to the provisions of subparagraph & art hereof, be used to reimburse Mortgagor for the cost of rebuilding or restoration of buildings and improvements on the Premises. In all other cases, such insurance proceeds may. at the option of Mortgagee, either be policed in reduction of the indebtedness secured hereby, whether due or not, or be held by the Mortgagee and used to reimburse Mortgagor for the cost of rebuilding or restoration of the buildings or improvements of the Fremises. In the event Mortgagee elects to apply said insurance proceeds in reduction of the indebtedness secured he eby all expenses and fees of collection shall first be deducted and paid to Mortgagee, and it is further coveranted and agreed that should the net insurance proceeds be insufficient to pay the then existing indebtedness solured hereby, together with all accrued interest thereon, fees and charges, Mortgagee may, at its sole election, declare the entire unpaid balance of the debt, secured hereby to be immediately due and payable, and the fairur to the payment thereof shall be a default hereunder.
- In the event Mortgagee elects to permit ary such insurance proceeds to be applied to pay for the cost of rebuilding or restoration of the buildings and improvements on the Premises, such funds will be made available for disbursement by Mortgagee; provided, however, that (i) should any insurance company have, in the opinion of Mortgagee, a defense against Mortgagor (but not against ortgagee) to any claim for payment due to damage or destruction of the Premises or any part thereof by reason of fice or other casualty, submitted by Mortgagee or any party on behalf of Mortgagee, or should such Company raise any defense against Mortgagee (but not against Mortgagor) to such payment or (ii) should the net proceeds of such insurance collected by Mortgagee together with any funds deposited by Mortgagor with Mortgagee be less than the extimated cost of the requisite work as determined by Mortgageee, which estimate shall include a reasonable continuncy, then in either case Mortgagee may, at its option, whether or not Mortgagee has received funds from an insurance settlements, declare the unpaid balance of the debt secured hereby to be immediately due and payable, and Mortgagee may then treat the same as in the case of any other default hereunder. In the event such proceed, are applied toward restoration or rebuilding, the buildings and improvements shall be so restored or rebuilt as to be of at least equal value and substantially the same character as prior to such damage or destruction. Such proceeds shall be made available, from time to time, upon the Mortgagee being furnished with satisfactory uvidence of the estimated cost of completion thereof and with such architect's certificates, waivers of lien, contractors' sworn statements and other evidence of cost and of payments, including insurance against mechanic's liens ind/or a performance bond or bonds in form satisfactory to Mortgagee which shall be the sole or a dual obligee, and with bonds shall be written with such surety company or companies as may be satisfactory to Mortgagee. All plans and specifications for such rebuilding or restorations shall be presented to and approved by Mortgagee prior to the commencement of any such repair or rebuilding. Disbursement of such insurance proceeds shall not exceed ninety percent (90%) of the value of the work performed from time to time, and at all times the undisbursed balance of said proceeds remaining in the hands of the Mortgagee shall be at least sufficient to pay for the cost of completion of the work free and clear of liens.
- In case of loss after foreclosure proceedings have been instituted, the proceeds of any such insurance policies, if not applied as aforesaid in rebuilding or restoring the building or improvements, shall be used to pay the amount due in accordance with any decree of foreclosure, that may be entered in any such poceedings, and the balance, if any, shall be paid to the owner of the equity of redemption if he shall then be entitled to the same, or as the court may direct. In case of the foreclosure of this Mortgage, the court in its decree may provide that the Mortgagee's clause attached to each of said insurance policies may be cancelled and that the decree may further provide that in case of one or more redemptions under said decree, pursuant to the statute in such case made and provided, then and in every such case, each successive redemptor may cause the preceding loss clause attached to each insurance policy to be cancelled and a new loss clause to the attached hereto, making the loss thereunder payable to such redemptor. In the event of foreclosure sale, Mortgagee is hereby authorized, without the consent of Mortgagor, to assign any and all insurance policies to the purchaser at the sale, or to take such other steps as Mortgagee may deem advisable, to cause the interest of such purchaser to be protected by any of the said insurance policies.

Nothing contained in this Mortgage shall create any responsibility or obligation on the Mortgagee to collect any amount owing on any insurance policy; to rebuild, repair or replace any damaged or destroyed portion of the Premises or any improvements thereon; or to perform any act hereunder.

7. Mortgagor hereby assigns, transfers and sets over unto Mortgagee the entire proceeds of any award or any claim for damages for all or any part of the Premises taken or damaged under the power of eminent domain or by condemnation. The Mortgagor, hereby empowers Mortgagee, in the Mortgagee's sole discretion, to settle, compromise and adjust any and all claims or rights arising under any condemnation or eminent domain

proceeding relating to the hourses of any content thereof. Nothing obtained in the Montgage shall create any responsibility or obligation on a Montgage of a plant of the Premises or any improvements thereon or to perform any act hereunder. Montgages may elect to apply the proceeds of the award upon or in reduction of the indebtedness secured hereby, whether due or not, or to require Montgager to restore or rebuild, in which event the proceeds shall be held by Montgages and used to reimburse Montgager for the cost of the rebuilding or restoring of buildings or improvements on the Premises, in accordance with plans and specifications to destroyed buildings or improvements under the terms of any lease or leases which are or may be prior to the lient of this Montgage and if such taking does not result in cancellation or termination of such lease, the award shall first be used to reimburse Montgagor for the cost of rebuilding or restoring of buildings or improvements on the Premises, provided Montgagor is not then in default under this Montgage. In the event Montgagor is required or authorized, by Montgagee's election as aforesaid, to rebuild or restore, the proceeds of the award shall be paid out in the same manner as is provided for the payment of insurance proceeds toward the cost of rebuilding or restoration. If the amount of such award is insufficient to cover the cost of rebuilding or restoration. If the amount of such award is insufficient to cover the cost of rebuilding or restoration, Montgagor shall pay such costs in excess of the award, before being entitled to reimbursement out of the award. Any surplus which may remain out of said award after payment of such costs of rebuilding or restoration and the option of Montgagor, be applied on account of the indebtedness secured hereby or be paid to any other party entitled thereto.

- 8. In the event that the Mortgagor falls to make any payment or perform any act required hereunder, the Mortgagee may, but need not, make said payment or perform any act in any form and manner deemed expedient, and may, but need not, make full or partial, payments of principal or interest on prior encumbrances, it any, and outchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or receim from any tax sale or forfeiture affecting said Promises or contest any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, includes attorneys' fees, and any other moneys advanced by Mortgagee to protect the mortgaged Premises and the lin hereof, plus reasonable compensation to Mortgagee for each matter concerning which action herein authorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the rate payable on the principal outstanding under the Notes inaction of Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default hereunder on the part of Mortgagor.
- 9. The flortgages miking any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procurred from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- by this Mortgagee shall, notwithstanding any hirg in the Note or in this Mortgage to the contrary, become due and payable (a) immediately in the case of defant under the terms of the Notes; (b) immediately in the event Mortgager shall, without the prior written consent of Mortgagee, sell, transfer, convey, encumber, or assign the title to all or any portion of the Premises, or the rents, issues, or profits therefrom, whether by operation of law, voluntarily or otherwise, or whall contract to do any of the foregoing, or shall grant an option to enter into a contract to do any of the foregoing, including, but not limited to, transfer to an Illinois Land Irust, or (c) immediately when default shall occur in the performance of any other agreement of the Mortgagor herein contained.
- Mortgages shall have the right to foreclose the lien hereof. In any suit to foreclose the tien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgages for attorneys fees, Mortgages's fees, appraiser's fees, outlays for documentary and expent evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) or presuming all such abstracts of title, title searches and examinations, guarantee policies, formers certificates, and similar data and assurances with respect to title as Mortgages may deem to be reasonably necessary either to prosecute such suit or to evidence to biddens at any sale which may be had pursuant to such decree the fire condition of the title to or the value of the Premises. All expenditures and expenses of the nature in this parameter mentioned shall become so much additional indebtedness secured hereby and immediately due and payable, with interest thereon at the rate payable on outstanding principal under the Notes, when paid or incurred by Mortgages in connection with (a) any proceeding, including probate and bankruptcy proceedings, to which either of them shall be a party, either as plaintiff, claimant or defendant, by reason of this Mortgage or any indebtedness hereby recured; (b) preparations for the commencement of any suit for the foreclesure hereof after accrual of such right to foreclose whether or not actually commenced; or (c) preparations for the defense of any threatened suit or proceeding which might affect the Premises or the security hereof, whether or not actually commenced.
- 12. The proceeds of any foreclosure sale of the Premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including, but not limited to, all such items as are mentioned in the preceeding paragraph hereof; second, all other items which under the terms hereof, constitute secured indebtedness in addition to that evidenced by the Notes, with interest thereon as herein provided; third, all principal and interest remaining unpaid on other liabilities of Mortgagor to Mortgagee; fourth, any surplus to Mortgagor, its successor or assigns, as their rights may appear.
- 13. Upon, or at any time the filing of a bill to foreclose this Mortgage, the court in which such bill is filed may appoint a receiver of said Premises. Such appointment may be made either before or after sale, without notice, without regard to the solvency or insolvency or Mortgagor at the time of application for such receiver and without regard to the then value of the Premises or whether the same shall be then occupied as a homestead or not during the pendency of such foreclosure suit, and in case of a sale and a deficiency, during the full statutory period of redemption, whether there be rents, issues, and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the Premises during the whole of said period. The court from time to time may authorize the receiver to apply the net income payment in his hands in whole or in part of (1) indebtedness secured hereby, or any decree foreclosing this Mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; (2) the deficiency in case of a sale and deficiency.

- 14. No action for the enforcement of the line on of any provision hereof whell be subject to any defense which would not be good an available to the party in elposing sale in an action at law upon the Mores hereby secured.
- 15. Mortgagee shall have the right to inspect the Premises at all reasonable times and access thereto shall be permitted for that purpose.
- 16. Mortgagee has no duty to examine the title, location, existence or condition of the Premises, nor shall Mortgagee be obligated to record this Mrotgage or to exercise any power herein given unless expressly obligated by the terms hereof, nor be liable for any acts or omissions hereunder, except in case of its own gross negligence, or misconduct or that of the agents or employees of Mortgagee, and it may require indemnities satisfactory to it before exercising any power herein given.
- 17. Mortgagee shall release this Mortgage and the lien thereof by proper instrument upon presentation of satisfactory evidence that all indebtedness secured by this Mortgage has been fully paid.
- 18. This Mortgage and all provisions hereof, shall extend to and be binding upon Mortgagor and all persons claiming under or through Mortgagor, and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part hereof, whether or not such persons shall have executed the Notes or this Mortgage.
- 19. This Mortgage shall be governed by and interpreted according to the laws of the State of Illinois. In the event any provision of the Mortgage, or the Note, conflict with said law, such conflict shall not affect any other provision of the Mortgage, or the Notes which can be given effect without reference to the conflict. In thir tegind, the provisions of the Mortgage and the Note shall be deemed severable.
- 20. The Mortgagor hereby waives any and all rights of redemption from sale under any order or decree of foreclosure of this Mortgage, on its own behalf and on behalf of each and every person, except decree or judgment creditors of v'e Mirtgagor, acquiring any interest in or title to the Premises subsequent to the date of this Mortgage.
