Lot 55 in Miami Park Subdivision, being a subdivision of part of Lots 1, 2 and 3 in Circuit Court Partition of the South 1/2 of the Northeast 1/4 and the North 1/2 of the Southeast 1/4 and the Southwest 1/4 of the Southeast 1/4 of Section 25, Township 41 North, Range 12 East of the Third Principal Meridian, and also that part lying West of the East line of Road of the Northwest 1/4 of Section 30, Township 41 North, Range 13 East of the Third Principal Meridian, in Cook County, Illinois;
