#### MORTGAGE, ASSIGNMENT OF RENTS AND SECURITY AGREEMENT

THIS MORTGAGE, ASSIGNMENT OF RENTS AND SECURITY AGREEMENT (the "Mortgage") is made at Hodgkins, Illinois as of this lst day of May, 1992, by and between Vito Manzella and Theresa Manzella (also known as Teresa Manzella), his wife, as Joint Tenants (whether one or more, "Mortgagor"), and CERTIFIED GROCERS MIDWEST, INC., an Illinois corporation, having its principal office at One Certified Drive, in Hodgkins, Cook County, Illinois ("Mortgagee").

#### RECITALS:

A. Mortgagor is the guarantor of the indebtedness evidenced by a Secured Note (the "Note") of even date herewith, made by ROCCO & BENNY'S FINER FOODS. INC., an Illinois corporation ("Borrower"), payable to the order of Mortgagee and delivered in the amount of THIRTY SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$37,500.00) Mortgagor is an Officer/Director/Shareholder of Borrower and as such will benefit from the loan evidenced by the Note (the "Loan"). As a condition to making the Loan, Mortgagee has required Mortgagor to execute a Continuing surranty and Subordination Agreement of even date herewith guaranteeing erisin obligations of Borrower including the Note and this mortgage to secure the Note. The Note provides for interest on the unpaid balance thereof at the rate specified therein; the remaining balance of principal and account and unpaid interest on the Note is payable in full on or before November 15, 194 as provided in the Note; and all of said principal and interest is payable in lawful money of the United States of America at the office of Mortgagee, of at such place as the legal holder of the Note may from time to time appoint in writing.

B. The terms, conditions, provisions and covenants of the Note are incorporated herein as if fully set forth herein.

#### ACREEMENTS:

NOW, THEREFORE, for the purpose of inducing Mortgagee to make the Loan, to further secure the payment of the principal of and interest on the Note and to secure the payment of all other sums which may be due at any time under the Note, this Mortgage, or any other of the Loar Documents (as the term is defined in Exhibit B attached hereto and incorporated overin by this reference) and the performance of the covenants and agreements herein contained to be performed by Mortgagor, Mortgagor hereby mortgages, conveys and warrants unto Mortgagee, its successors and assigns, the following describer real estate situated in the County of COOK and State of Illinois, to wit:

with a11buildings, improvements, tenements, easements, fixtures and appurtenances belonging thereto, and all rents, issues and profits thereof for so long and during all such times as Mortgagor may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily) and all apparatus, equipment or articles now or hereafter therein or thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single units or centrally controlled), and ventilation, including, without restricting the foregoing, screens, window shades, storm doors and windows, floor coverings, awnings, stoves, water heaters, built in ovens, washers, dryers and disposal units. All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment articles hereafter placed in the premises shall be considered as constituting part of the real estate, and all of which together with the real estate are beginnafter sometimes referred to as the "premises" or the "mortgaged propercy."

TO HAVE AND TO HOLD the mortgaged property unto Mortgagee, its successors and assigns, forever for the purposes and uses herein set forth, hereby releasing and waiving all rights of Mortgagor under and by virtue of all applicable homestead exemption valuation and appraisement laws in respect to the premises hereby conveyed.

Mortgagor covenants and agrees in the following:

- 1. Mortgagor shall (i) pay all indebtedness secured hereby when due; and (ii) punctually perform and observe all of the requirements of the Note, this Mortgage and the other Loan Documents. The terms and provisions of the Loan Documents are hereby incorporated herein by this reference as fully and with the same effect as if set forth herein at length. Mortgagor shall have the privilege of making prepayment on the principal of the Note (in addition to the required payments thereunder) in accordance with the terms and conditions set forth in the Note, but not otherwise.
- 2. Mortgagor shall (i) promptly repair, restore or rebuild any buildings or improvements now or hereafter constituting part of the premises which may become damaged or be destroyed; (ii) keep the premises in good condition and repair, without waste, and free from mechanics' or other liens of claims for liens not expressly subordinated to the lien hereof; (iii) pay, when due, any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and, upon request, exhibit satisfactory evidence of the discharge of such prior lien to Mortgagee; (iv) complete, within a reasonable time, any building or buildings or other improvements now or at any time in process of erection upon the above described real estate; (v) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof; (vi) make no material alterations or additions to the premises except as required by law or municipal ordinance or as consented to in writing by Mortgagee, but in no event suffer or permit any removal or demolition of any part of the premises, nor suffer or permit the premises to be

used for a purpose other than for which the premises are presently used or represented to Mortgagee to be used; (vii) appear in and defend any proceedings which, in the opinion of Mortgagee, impair the security afforded hereby; (viii) refrain from any action and correct any condition which would increase the risk or other hazard to the premises; (ix) comply with any restriction of record with respect to the premises and the use thereof and observe and comply with any condition necessary to preserve and extend any and all rights, licenses, permits (including, without limitation, zoning ordinances, special exceptions and nonconforming uses), privileges and concessions which are applicable to the premises or its use and occupancy; and (x) cause the premises to be managed in a competent and professional manner.

At the request of Mortgagee at any time and from time to time, Mortgagor agrees to deposit with Mortgagee on each day on which an installment payment is to be made on the Note, until the indebtedness secured hereby shall have been fully paid an amount equal to the amount estimated by Mortgagee to be annually payable with regard to the premises, for real estate taxes, special assessment levies, property insurance premiums, and any similar charge divided by the number of installments to be made on the Note in each year, plus an amount equal to the theretofore accrued unpaid obligation for such taxes, assessments, premiums and other charges as estimated by Mortgagee in respect to which deposits have not been made; provided that Mortgagee shall not require any such deposits from Mortgagor as long as Mortgagor is depositing such amounts with any other mortgagee whose lied with respect to the premises is superior to the lien of this Mortgage and Mortgagor furnishes adequate evidence thereof to Mortgagee. Said sums shall be herd by Mortgagee, without any allowance or payment of interest, for application for payment of taxes, special assessment levies and insurance premiums when due. Crtgagor further agrees to deposit, within ten (10) days after receipt of demand therefor, any deficiency in the aggregate of such monthly deposits, in the event the tax, special assessment levies or insurance bills when issued, shall be in excess of the aggregate of such deposit being held for payment of such charge. All such deposits are pledged as additional security for payment of the indeptedness secured hereby and, in the event of a default in any of the provisions contained in this Mortgage or in the Note, at the option of Mortgagee, Mortgagee may, without being required to do so, apply any monies at the time on deposit to payment, in whole or in part, of any of Mortgagor's obligations herein or in the Note contained in such order and manner as Mortgagee may elect. Mortgagee shall be under no obligation to obtain the tax, special assessment levies or insurance bills or to ascertain the correctness thereof, nor shall Mortgagee be obligated to attend to the payment thereof, except on timely presentation of such bills; provided, however, Mortgagee may make payments authorized in this Mortgage relating to taxes or assessments or insurance bills according to any bill, statement or estimate which it may elect to procure from the appropriate public office or company, as the case may be, without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof. Mortgagor shall pay, before any penalty attaches, all taxes, assessments, water charges, sewer charges and other charges against the premises, for which sums as aforesaid are not deposited with Mortgagee.

- 4. In the event of the enactment of any law deducting from the value of the premises any mortgage lien thereon, or imposing upon Mortgagee the payment of all or part of the taxes, charges or assessments previously paid by Mortgagor pursuant to this Mortgage, or changing the law relating to the taxation of mortgages, debts secured by mortgages or Mortgagee's interest in the premises so as to impose new incidents of tax on Mortgagee, then Mortgagor shall pay such taxes or assessments or shall reimburse Mortgagee therefor; provided, however, that if in the opinion of counsel to Mortgagee such payment cannot lawfully be made by Mortgagor, then Mortgagee may, at Mortgagee's option, declare all of the sums secured by this Mortgage to be immediately due and payable without prior notice to Mortgagor.
- Until all unpaid indebtedness secured hereby is fully paid (or in case of foreclosure, until the expiration of the period of redemption, if any) shall keep the buildings and improvements now or hereafter constituting part of the premises insured in an amount satisfactory to Mortgagee (but Mortgagee shall not require an amount exceeding the full insurable value of such buildings and improvements) against damage by fire, lightening and risks covered by the so-called "Extended Coverage" endorsement together with "vandalism and malicious mischief" and "sprinkler leakage" endorsements, or by the so-called all perils" endorsement and such other risks as Mortgagee may reasonably requ<sup>3</sup>re. Mortgagor shall also maintain comprehensive general public liability insurance against bodily injury and property damage in any way arising in connection with the premises with such limits as Mortgagee may reasonably In connection with the premises with such limits as Mortgagee may reasonably require and in any event not less than \$1,000,000.00 single limit coverage. Mortgagor further agrees to maintain in full force and effect such other insurance as Mortgages may require, including any required flood insurance, in such amounts as shall be adequate to protect the mortgaged property, and in companies approved by Mortgagee during said period or periods, and each shall contain the standard mortgare clause making all sums recoverable upon said policies payable to Mortgage. Acceptance by Mortgagee of an insurance policy deposited by Mortgagor or the purchase of insurance by Mortgagee upon Mortgagor's failure so to do, will not of itself, constitute an admission that building and improvement portions of the premises are fully, adequately or erly insured. Mortgagor covenants to sign upon demand, or Mortgagoe may or endorse in Mortgagor's behalf all necessary proofs of loss, receipts, ases, and other papers required of Mortgagor to be signed by the insurance anies. At the option of Mortgagee, all or part of the proceeds of any such properly insured. sign or releases, companies. may be applied either to the restoration of the premises or to the of the indebtedness secured hereby. In the event the premises are Mortgagee may pay the insurance proceeds in accordance with insurance reduction construction loan payment procedures prescribed or approved by Mortgagee.
- 6. If the premises, or any part thereof, shall be taken by condemnation or eminent domain, Mortgagee is hereby empowered to collect and receive all compensation which may be paid for any mortgaged property taken or for damages to any mortgaged property not taken, and all condemnation money so received shall be forthwith applied by Mortgagee, as it may elect, to the immediate of reduction of the indebtedness secured hereby or to the repair and restoration

of any mortgaged property so damaged, upon the same conditions and with the same effect as provided in paragraph 5 with reference to the application of insurance moneys recovered by Mortgagee. If any portion of or interest in the premises is taken by condemnation or eminent domain, and the remaining portion of the premises is not, in the judgment of Mortgagee, a complete economic unit having equivalent value to the premises as it existed prior to the taking, then, at the option of Mortgagee, the entire indebtedness secured hereby shall immediately become due.

- Upon default of Mortgagor to pay or perform any agreement herein, Mortgagee may, but need not, make any payment or perform any act required by Mortgagor in this Mortgage in any form and manner deemed expedient, and, in any event, may, but need not make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any or forfeiture regarding the premises or contest any tax or sale If any part of the indebtedness secured hereby is used directly or assessment. indirectly to satisfy, in whole or in part, any prior encumbrance upon the premises or any part thereof, then Mortgagee shall be subrogated to the rights of the holder thereof in and to such other encumbrance and any security held by such holder, and shall have the benefit of the priority of the same. All monies paid icc any of the purposes herein authorized or by reason of the failure of Morre. For to perform the covenants in this Mortgage contained, and all expenses paid or incurred in connection there-with, including, without limitation, attorneys fees, and any other monies advanced by Mortgagee to protect the premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the default rate stated in the Note. Without limiting in any way the generality of the foregoing, all expenditures and expenses when paid or incurred by Mortgagee in connection with (i) any proceeding, including, without limitation, probate and bankruptcy proceedings, to which Mortgages shall be party, either as plaintiff, claimant, or defendant by reason of this lift tagge or any indebtedness secured hereby; or (ii) preparations for the commencement of any suit for the foreclosure hereof after accrual of such right to foreclose, whether or not actually commenced; or (iii) preparations for the defense of any threatened suit or proceedings which might affect the premises or the lecurity hereof, whether or not actually commenced; or (iv) enforcement in any way of the provisions of the Note or of this Mortgage, shall become so much additional indebtedness secured hereby and payable on demand and with interest as afore ald. Any such action of Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default on the part of Mortgagor under the Note or this Mortgage. Each right, power or remedy herein conferred upon Morrgagee is cumulative with every other right of Mortgagee whether herein or by law or equity conferred.
- 8. Mortgagor shall comply with and observe Mortgagor's obligations as landlord under all leases of the premises or any part or reof. Mortgagor, at Mortgagee's request, shall furnish Mortgagee with executed copies of all leases

now existing or hereafter made letting all or any part of the premises, and all leases now or hereafter entered into will be in form and substance subject to the approval of Mortgagee. Mortgager shall not, without Mortgagee's written consent, execute, modify, surrender or terminate, either orally or in writing, any lease now existing or hereafter made letting all or part of the premises providing for a term of one (1) year or more, permit an assignment or sublease of such a lease without Mortgagee's written consent, or request or consent to the subordination of any lease letting all or any part of the premises to any lien subordinate to this Mortgage. Upon Mortgagee's request, Mortgagor shall assign to Mortgagee as additional security all leases now existing or hereafter made letting all or any part of the premises.

As part of the consideration for the indebtedness evidenced by the Note, Mortga(0) hereby absolutely and unconditionally assigns and transfers to Mortgagee the felts and revenues of the premises, including those now due, past due, or to become due by virtue of any lease or other agreement for the occupancy or use of all or any part of the premises. Mortgagor hereby authorizes Mortgagee or Mortgagee's agents to collect the aforesaid rents and revenues and hereby directs each tenant of the premises to pay such rents to Mortgagee or Mortgagee's agents; provided, however, that prior to written notice given by Mortgagee to Mortgagor of the breach by Mortgagor of any covenant or agreement of Mortgagor in this Mortgagoe, Mortgagor shall collect and receive all rents and reverues of the premises as trustee for the benefit of Mortgagee and Mortgagor, to apply the rents and revenues so collected to the sums secured by this Mortgage with the balance, so long as no such breach has occurred, to the account of Mortgagor Mortgagor agrees that each tenant of the premises shall pay such rents to Mortgagee or Mortgagee's agents on Mortgagee's written demand therefor without liability on the part of said tenant to inquire further as to the existence of a default by Mortgagor. Mortgagor hereby covenants that Mortgagor has not executed any prior assignment of said rents, that Mortgagor has not performed, and will not perform any acts or has not executed, and will not execute, any instruments which would prevent Mortgagee from exercising its rights under this paragraph, and that at the time of execution of this Mortgage there has been no anticipation or prepayment of any of the rents of the precises for more than one month prior to the due date of such rent. Mortgagor fulther covenants that Mortgagor will not hereafter collect or accept payment of any rents of the premises more than one month prior to the due date of such rent it the rents of the premises are not sufficient to meet the costs of taking control of and managing the premises and collecting the rents, any funds expended by Kortgagee for such purposes shall become indebtedness of Mortgagor to Mortgagee secured by this Mortgage, payable upon demand and shall bear interest from the date of disbursement at the rate stated in the Note. The entering upon and taking and maintaining of control of the premises by Mortgagee or a receiver and the application of rents as provided herein shall not cure or waive any default hereunder or invalidate any other right or remedy of Mortgagee hereunder. release of this Mortgage, this assignment of rents of the premises shall terminate.

- 10. Mortgagor shall pay or cause to be paid each item of indebtedness herein and in the Note, both principal and interest, when due according to the terms hereof. At the option of Mortgagee, and without notice to or demand upon Mortgagor or to any other person obligated or bound by the Note, all unpaid secured by this Mortgage shall become due and payable, notwithstanding anything in the Note, this Mortgage or any other document or instrument evidencing, securing or guaranteeing the indebtedness secured hereby to the contrary, (i) upon default in making payment of any installment of principal or interest on the Note or in the payment of any other indebtedness arising under the Note or this Mortgage; or (ii) ten (10) days after default shall occur in the performance of any other agreement of Mortgagor herein contained and if such default shall not be cured within such ten (10) days; or (iii) upon any other default specified in the Note or any other document or instrument securing the Note; or (iv) upon default by Mortgagor under any other mortgage or trust deed encumbering the premises.
- 11. If Mortgagor or any other person liable for the payment of the indebtedness secured hereby shall voluntarily file a petition under the Federal Bankruptcy Code or under any state bankruptcy or insolvency law or an answer in an involuntary proceeding admitting insolvency or inability to pay debts, or if Mortgagor or any other person liable for the payment of the indebtedness secured hereby shall fail to obtain a vacation or stay of involuntary proceedings brought for the reorganization, dissolution or liquidation of Mortgagor or such other person, of If Mortgagor or any other person liable for the payment of the indebtedness hereby secured shall be adjudged a bankrupt, or if a trustee or receiver shall be appointed for Mortgagor or such other person or its or their property, or if Mortgagor or any other person liable for the payment of the indebtedness secured hereby shall make an assignment for the benefit of its creditors, then all of the sums secured by this Mortgage shall forthwith be and become immediately due and payable without prior notice to Mortgagor.
- 12. When the indebtedness secured hereby shall become due, whether by acceleration or otherwise, Mortgagee shall have the right to foreclose the lien hereof in accordance with the Illinois Mortgage Foreclosure Act, Ill. Rev. Stat. ch. 110, para. 15-1101 et seq. (1987) (the "Act") and co exercise any other remedies of Mortgagee provided in the Note, this Mortgage two other Loan Documents, or which Mortgagee may have at law, at equity or otherwise. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness secured hereby in the decree of sale, all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee for attorneys' fees, appraisers' fees, outlays for documentary and expert evidence, stenographers' charges, publication costs, costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches and examinations, title insurance policies, and similar data and assurance with respect to title as Mortgagee may deem reasonably necessary either to prosecute such suit or to evidence to bidders at

sales which may be had pursuant to such decree the true conditions of the title to or the value of the premises, and any other expenses and expenditures which may be paid or incurred by or on behalf of Mortgagee and permitted by the Act to be included in such decree. All expenditures and expenses of the nature mentioned in this paragraph, and such other expenses and fees as may be incurred in the protection of the premises and rents and income therefrom and the maintenance of the lien of this Mortgage, including the fees of any attorney employed by Mortgagee in any litigation or proceedings affecting this the or the premises, including probate and bankruptcy Note in preparation of the commencement or defense of any proceedings, or threatened suit or proceeding, or otherwise in dealing specifically therewith, shall be so much additional indebtedness secured hereby and shall be immediately due and payable by Mortgagor, with interest thereon at the default rate stated in the Note until paid.

13. When the indebtedness secured hereby shall become due, whether by acceleration or otherwise, exercise by Mortgagee of its call rights under the Note or otherwise, or if Mortgagee has a right to institute foreclosure proceedings, Mortgagor shill, forthwith upon demand of Mortgagee, surrender to Mortgagee, and Mortgagee shall be entitled to be placed in possession of the premises as provided in the Act, and Mortgagee, in its discretion and pursuant to court order, may enter upon and take and maintain possession of all or any part of the premises, together with all documents, books, records, papers, and accounts of Mortgagor or the then owner of the premises relating thereto, and may exclude Mortgagor, such owner, and my agents and servants thereof wholly therefrom and may, on behalf of Mortgagor or such owner, or in its own name as Mortgages and under the powers herein greated: (i) hold, operate, manage, and control all or any part of the premises and conduct the business, if any, thereof, either personally or by its agency, with full power to use such measures, legal or equitable, as Mortgagee may deem necessary to enforce the payment or security of the rents, issues, deposits, profits, and avails of the premises, including without limitation actions for recovery of rent, actions in forcible detainer, and actions in distress for real, all without notice to Mortgagor; (ii) cancel or terminate any lease or sublease of all or any part of the premises for any cause or on any ground that would entitle Mortgagor to cancel the same; (iii) elect to disaffirm any lease or sublease of all or any part of the premises made subsequent to this Mortgage without Mortgagee's prior written consent; (iv) extend or modify any then existing leases and make new leases of all or any part of the premises, which extensions, modificacions, and new leases may provide for terms to expire, or for options to lessees to extend or renew terms to expire, beyond the maturity date of the loan evidenced by the Note and the issuance of a deed to a purchaser at a foreclosure sale, it being understood and agreed that any such leases, and the options or other such provisions to be contained therein, shall be binding upon Mortgagor, all persons whose interests in the premises are subject to the lien hereof, and the purchaser at any foreclosure sale, notwithstanding any redemption from sale, reinstatement, discharge of the indebtedness secured hereby, satisfaction of to any foreclosure decree, or issuance of any certificate of sale or deed to any

such purchaser; (v) make all necessary or proper repairs, decoration renewals, alterations, additions, replacements. betterments, and improvements in connection with the premises as may seem judicious to Mortgagee, to insure and reinsure the premises and all risks incidental to Mortgagee's possession, operation, and management thereof, and to receive all rents, issues, deposits, profits, and avails therefrom; and (vi) apply the net income, after allowing a reasonable fee for the collection thereof and for the management of the premises, to the payment of taxes or assessment, insurance premiums and other charges applicable to the premises, or in reduction of the indebtedness secured hereby in such order and manner as Mortgagee shall select. Without limiting the generality of the foregoing, Mortgagee shall have all power, authority and duties as provided in the Act. Nothing herein contained shall be construed as constituting Mortgagee a mortgagee in possession in the absence of the actual taking of possession of the premises.

14. Upon the filing of a complaint to foreclose this Mortgage or at any time thereafter, the court in which such complaint is filed may appoint upon petition of Mortgagee, and at Mortgagee's sole option, a receiver of the premises pursuant to the Act. Such appointment may be made either before or after sale, without notice, without regard to solvency or insolvency of Mortgagor at the time of application for such receiver, and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not; and Mortgagee reseaunder or any employee or agent thereof may be appointed as such receiver. Such receiver shall have all powers and duties prescribed by the Act, including the pover to make leases to be binding upon all parties, including Mortgagor, the purchaser at a sale pursuant to a judgment of foreclosure and any person acquiring an interest in the premises after entry of a judgment of foreclosure, all as provided in the Act. In addition, such receiver shall also have the power to extend or modify any then existing leases, which extensions and modifications may provide for terms to expire, or for options to lessees to extend or renew terms to expire, beyond the maturity date of the Note and beyond the date the issuance of a deed or deeds to a purchaser or purchasers at a foreclosure site it being understood and agreed that any such leases, and the options or other provisions to be contained therein, shall be binding on Mortgagor and all the persons whose interest in the premises are subject to the lien hereof and upon the purchaser at any foreclosure sale, notwithstanding any redemption, reinstatement, discharge of the indebtedness secured hereby, satisfaction of any foreclosure judgment, or issuance of any certificate of sale or deed to any purchaser. In addition, such receiver shall have the power to collect the rents, issues and profits of the premises during the pendency or such foreclosure suit and, in case of a sale and deficiency, during the full statutory period of redemption, if any, whether there be a redemption or not, as well as during any further times when Mortgagor, except for the intervention of such receiver, would be entitled to collection of such rents, issues and profits, and such receiver shall have all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. The court making
