

THIRTY FIFTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP OF THE MANORS OF OAK KNOLL CONDOMINIUM

THIS AMENDMENT is made and entered into this 14th day of May, 1992 by CENTEX REAL ESTATE CORPORATION, a Nevada corporation (hereinafter referred to as the "Declarant").

- 3. Exhibit "B" of the Declaration is hereby amended by (a) deleting page 1 of Exhibit "B" of the Declaration and substituting therefor page 1 of Exhibit "35B" attached hereto and (b) adding pages 73 and 74 of the attached Exhibit "35B" to Exhibit "B" of the Declaration.
- 4. The Declaration in Leveby amended by deleting Exhibit "C" of the Declaration and substituting therefore Exhibit "350" attached hereto.
- 5. The Added Common Elementr (as defined in the Declaration) annexed by this instrument are hereby granted and conveyed to the grantees of all Units (as defined in the Declaration) of The Manors of Oak Knoll Condominium, including the grantees of Units heretofore conveyed, all as set forth in the Declaration.
- 6. Except as expressly set forth here n, the Declaration shall remain in full force and effect in accordance with its terms.
