THIS INDENTURE made May 19,

, 1992, between Frank L. Waner and
Cathy L. Waner, his wife

herein referred to as "Mortgagors," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of

Thirty Three Thousand (\$33,000.00) ----- Dollars, evidenced by one certain Instalment Note of the Mortgagors of even date herewith, made payable to THE ORDER OF BEARER

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest from May 15, 1992 on the balance of principal remaining from time to time unpaid at the rate of 9.00 percent per annum in instalments (including principal and interest) as follows:

Four Hundred Eighteen and 03/100 (\$418.03) ----- Dollars or more on the 1st day of July 1992, and Four Hundred Eighteen and 03/100 ----- Dollars or more on the 1st day of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the 1st day of June, 2002. All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each instalment unless paid when due shall bear interest at the rate of 9.00 per annum, and all of said principal and interest being made payable at such banking house or trust company in Westchester, Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of Milton and Joan Berlin, HMCORP, 10625 W. NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of their estate, right, title, and interest therein, situated, lying and being in the Village of Oak Lawn COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

All of Block 11 (except the North 255.50 feet thereof) and (except the East 1/2 thereof) and (except the South 33 feet taken for streets) in Kaup's Addition to Oak Lawn being a Subdivision of Lot 5 in the Subdivision of the West 1/2 of the Northeast 1/4 and all of the Northwest 1/4 of Section 4, Township 37 North, Range 13, East of the Third Meridian, in Cook County, Illinois.

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purpose, and in the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Law of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.
