### ORDINANCE NUMBER 1278 (1992) VILLAGE OF CRESTWOOD

AN ORDINANCE ANNEXING LOT 55
(EXCEPT THE NORTH 200 FEET THEREOF)
IN BARTLETT'S CICERO AVENUE FARMS SUBDIVISION

(14157 South Lavergne Avenue)

CARL J. BACKSTROM and SANDRA D. BACKSTROM, his wife, having fired with the Clerk of the Village of Crestwood, their verified retition, duly executed and sworn to, requesting that the Cerritory described in Section "One" below be annexed to the Village of Crestwood; and

The Village Board finding that (1) Carl J. Backstrom and Sandra D. Backstrom, his wife, are the owners of record and holders of all interest in and to the said territory;

- (2) they are the only electors residing on said territory;
- (3) said territory is not within the corporate limits of any municipality; and (4) said territory is contiguous to the Village of Crestwood;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Poard of Trustees of the Village of Crestwood:

Section One: That the territory legally described as:

Lot 55 (except the North 200 Feet thereof) in Frederick H. Bartlett Cicero Avenue Farms, being a subdivision of part of the Southeast 1/4 lying East of Ditch and South of Main Road (except the South 33 feet conveyed to railroad) of Section 4, Township 36 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois, commonly known as 14157 Lavergne, Crestwood, Illinois,

be, and the same is hereby, annexed to and made a part of the Village of Crestwood, and shall be a part of the Village of Crestwood; and all Ordinances of the Village of Crestwood shall be in full force and effect therein.

Section Two: By reason thereof, the new corporate boundary of the Village of Crestwood shall extend to the far right-of-way of Lavergne Avenue bordering upon the territory annexed.

Section Three: That the Village Clerk shall file a plat of annexation describing said property, together with a duly certified copy of this Ordinance, in the office of the Recorder of Cook County, Illinois.

Section Four: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
