

- 2. Charges; Liens. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Montgage. Borrower shall promptly furnish to Lender receipts evidencing such payments. A premiums on insurance policies shall be paid by Borrower making payment, when due, directly to the insurance carrier or the holder of 3:5 Prior Mortgage, if required

All insurance policies and renewals thereof shall be in form acceptable to Lender and shall include a standard mortgage clause in layor of and form acceptable to Lender. Borrower shall promptly furnish to Lender all renewal notices and all receipts of paid premiums. In the event of loss, Borrower shall give prompt notice to the insurance carrier and Lender. Lender may make proof of loss if not made promptly by Borrower.

Unless Lender and Borrower otherwise agree in writing. Insurance proceeds shall be applied to restoration or repair of the Property damages, providing such restoration or repair is economically leasible, the security of this Mortgage is not thereby impaired, and the Borrower or its beneficiary, if applicable, intends to maintain the Property as the principal residence. If such restoration or repair is not economically feasible or if the security of this Mortgage would be impaired, the insurance proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. - 10. Remedies Cumulative. All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this Mortgage or afforded by law or equity, and may be exercised concurrently, independently or successively.
- 11. Succesors and Assigns Bound; Joint and Several Liability; Captions. The covenants and agreements herein contained shall bind, and the rights hereunder shall inure to, the respective successors and assigns of Lender and Borrows. All covenants and agreements of Borrower shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereo.
- 12. Notice. Except for any notice required under applicable law to be given in another manner, (a) any notice to Borrower provided in this Mortgage shall be given by mailing such notice by certified mail addressed to Borrower at the Propont Address or at such other address as Borrower may designate by notice to Lender as provided herein, and (b) any notice to Lender shall be given by certified mail, return receipt requested, to Lender's address stated herein or to such other address as Lender may designate by notice to Borrower as provided herein. Any notice provided for in this Mortgage shall be deemed to have been given to Borrower or Lender when given in the manner designated narein.
- 13. Governing Law; Severability. This Mortgage shall be governed by the Law of the State of Illinois, including without limitation the provisions of Illinois. Relised Statute Chapter 17. Sections 6405, 6406 and 6407; and 312.2. In the event that any provisions or clause of his Mortgage, the Note or Loan Agreement conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Loan Agreement or Note which can be given effect without the conflicting provision, and to this end the provisions of the Mortgage, the Note and Loan Agreement are declared to be severable.
- 14. Borrower's Copy. Borrower (or Borrower's beneficiary, if applicable) shall be furnished a conformed copy of the Note and this Mortgage at the time of execution or after recordation hereof.
- 15. Transfer of the Property; Assumption. If all or any part of the Property or an interest therein (including beneficial interest in the land trust, if applicable) is sold, assigned, transferred or further encumbered by Borrower or its beneficiary (including modification or amendment of the Prior Nortgage to increase the indebtedness thereby secured) without Lender's prior written consent, or the Propercy is no longer the principal residence of Borrower or its beneficiary, if applicable, Lender may, at Lender's option, declare all the sums secured by this Mortgage to be immediately due and psyable.
  - If the Lender exercises such option to accelerate, Lender shall mail Borrower notice of acceleration in accordance with paragraph 12 hereof. Such notice shall provide a period of not less than 30 days from the date the notice is alled within which Borrower may pay the sums declared due. If Borrower fails to pay such sums prior to the explication of such period, Lender may, without further notice or demand on Borrower, invoka any remedies permitted by paragraph 16 hereof.
- 16. Acceleration; Remedies. Upon Borrower's (or Borrower's beneficiary, if applicable) breach of any covenant or agreement of Borrower in the Loan Agreement, Note or this Mortgage, including the covenants to pay when due any sums secured by this Mortgage of as set forth in the Note or Agreement, Lender prior to acceleration shall mail notice to Borrower as provided in paragraph 12 hereof specifying: (1) the breach; (2) the action required to cure such breach; (3) a date, not less than 30 days from the date the notice is mailed to Borrower, by which such breach must be cured; and (4) that failure to cure such breach on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage, foreclosure by judicial proceeding and sale of the Property. If the breach is not cured on or before the date specified in the notice, Lender at Lender's option may declare all of the sums this Mortgage to be immediately due and payable without further demand and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorney's fees, and costs of documentary evidence and little reports.
- 17. Assignment of Rents; Appointment of Receiver; Lender in Possession.
