of the Home Owners Loan Act of 1933 ("HOLA"), appointed the Resolution Trust Corporation as Conservator for New
Great American;

WHEREAS, the Receiver transferred the assets and certain liabilities of Old Great American to New Great American,
including certain Mortgages-Deed of Trust which are subject to this Assignment, pursuant to a Purchase and
Assumption Agreement dated May 25, 1990;

WHEREAS, on September 21, 1990 the OTS, by order No. 90-1750 and 90-1749, appointed the Resolution Trust
Corporation as the Receiver for New Great American.

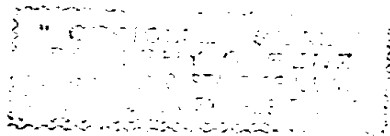
