Section 421 of the Real Property Law expressly provides whom must execute the certificate of discharge in specific cases and also provides among other things that (1) no certificate shall purport to discharge more than one mortgage, except the mortgages affected by instruments of consolidation, spreader, modification or correction may be included in one certificate if the instruments are set forth in detail in a separate paragraph; (2) if the mortgage has been canceled in whole or in part, the certificate shall set forth (a) the date of each extinguishment in the chain of title of the person or persons signing the certificate, (b) the names of the assignor and assignee, (c) the interest assigned, and (d) if the assignee has been recorded, the book and page where it has been recorded or the serial number of its recording; (3) if the assignment is being recorded simultaneously with the certificate of discharge, the certificate of discharge shall so state; and (4) if the mortgage has not been assigned or record the certificate shall state (a) if the mortgage is held by any fiduciary, including an executor or administrator, the certificate of discharge shall recite the name of the court and the venue of the proceedings in which his appointment was made or in which the order or decree vesting him with such title or authority was entered.
