## EXHIBIT A

### Legal Description

That part of the South Half of the North Half of the East Half of the East Half of the Southeast Quarter of Section 9, Township 36 North, Range 12 East of the Third Principal Meridian, bounded and described as follows:

Commencing at the Southeast corner of the said South Half of the North Half of the East Half of the East Half of the Southeast Quarter of Section 9, and running thence South 89 degrees 45 minutes 41 seconds West along the South line of said South Half of the North Half of the East Half of the East Half of the Southeast Quarter of Section 9, a distance of 282.50 feet to the place of beginning; thence continuing South 89 degrees 45 minutes 41 seconds West along the last described course, a distance of 340.01 feet to a point that is 33.00 feet East of the west line of said South Half of the North Half of the East Half of the East Half of the Southeast Quarter of Section 9; thence North 0 degrees 00 minutes 00 seconds East along a line 33.0 feet East of and parallel to the West line of said South Half of the North Half of the East Half of the East Half of the Southeast Quarter of Section 9, a distance of 661.70 feet to a point in the North line of said South Half of the North Half of the East Half of the East Half of the Southeast Quarter of Section 9; thence North 89 degrees 38 minutes 59 seconds East along said North line of the South Half of the North Half of the East Half of the East Half of the Southeast Quarter of Section 9, a distance of 672.29 feet to the Northeast corner of said South Half of the North Half of the East Half of the East Half of the Southeast Quarter of Section 9; thence South 0 degrees 01 minutes 10 seconds East along the East line of the Southeast Quarter of said Section 9, a distance of 15.0 feet to a point; thence South 89 degrees 38 minutes 59 seconds West, a distance of 260.14 feet to a point; thence South 0 degrees 15 minutes 10 seconds East, a distance of 260.0 feet to a point; thence North 89 degrees 38 minutes 59 seconds East, a distance of 239.08 feet to a point on the East line of said Southeast Quarter of Section 9, thence South 0 degrees 01 minutes 10 seconds East along said East line of the Southeast Quarter of Section 9, a distance of 172.91 feet to a point; thence South 89 degrees 45 minutes 41 seconds West, a distance of 283.37 feet to a point; thence South 0 degrees 15 minutes 10 seconds East, a distance of 215.0 feet to the place of beginning, all in Cook County, Illinois.
