

POURTH MODIFICATION OF SETTLEMENT AGREEMENT

THIS FOURTH MODIFICATION OF SETTLEMENT AGREEMENT is made and entered into this 1st day of May, 1992 by and between Devon Bank, an Illinois Banking Corporation ("Devon") and Gerald Donahue ("Donahue"), Thomas D. Harding ("Harding") and James R. Green ("Green").

On March 15, 1989, Devon, Donahue, Harding and Green entered into a Settlement Agreement, which was modified by the parties in August of 1990 (Settlement Agreement and its modifications are collectively "Agreement"), and modified again by the parties on February 25, 1991 and February 1, 1992.

Devon and the parties now desire again to modify the Agreement.

NOW THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration of the receipt and sufficiency of which are hereby acknowledged and Depon's having entered into that certain Loan Subordination Agreement between .trelf and Gladstone Norwood Bank dated the 8th day of February, 1991, agree to and with each other as follows:

- This loan will meture in One Hundred Eighty Five (185) days, on November 2, 1992.
- Principal payments of \$700.00 plus accrued interest at the rate of Prime + 2%, floating, s'al. be due and payable on the 1st day of June and the 1st day of the lext four (4) months thereafter, with a final balloon payment due November 2, 1992.
- 3. Except as provided for hereir 711 of the other terms, conditions and provisions of the Agreement shall remain in full force and effect.
- 4. The defined terms in the Agreement shall have the same meaning in this Fourth Modification Agreement.

WHEREFORE, the undersigned have executed this Modification Agreement as of the date and year first above written.
