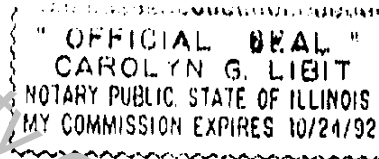

Article 5.

A member desiring to transfer the member's certificate shall give the cooperative thirty (30) days written notice and shall give the full name and address of the proposed transferee. As a part of the member's notice to the cooperative, the member shall attach the proposed transferee's signed application for membership. The application shall be in uniform form prescribed by the board of directors; shall contain such information relating to the applicant as the form shall specify; shall include a commitment to observe the cooperative's rules and by-laws; and shall authorize the obtaining of a full credit report from such credit reporting agency as the board of directors designate, for payment of which the member shall be responsible. The secretary shall give notice of the application to all directors and a directors' meeting shall be held promptly at which the applicant shall appear. The directors shall consider the applicant in the light of the goals stated in by-law Section 6.10. If the board of directors disapproves an applicant, the transfer may not be consummated. If the board of directors fails to act on the application 45 days after receipt of the member's written notice, such failure to act shall be deemed to be approval.

No pledge of a member's certificate shall be valid without express approval of the board of directors, but the board of directors may from time to time enter into "recognition agreements" deemed by the board of directors to be fair and workable, to enable members to obtain loans from banks and other lenders.

If a member attempts to transfer, pledge or otherwise dispose of the member's certificate without complying with the by-laws, such intended disposition shall be of no effect.

A member's certificate of membership shall pertain to a specific apartment to which the member may have the right of occupancy so long as the member observes the cooperative's rules, by-laws, and these articles and all the substantive terms of the occupancy agreement adopted by the cooperative for uniform application to all apartments.

The member's occupancy shall be governed by the terms of a uniform written Occupancy Agreement adopted by the Cooperative.
