done by authority hereof.

Third parties without actual notice may rely upon the power granted
under this Limited Power of Attorney upon the exercise of such power
by the Attorney-in-Fact that all conditions precedent to such exercise
of power have been satisfied and that this Limited Power of Attorney
has not been revoked unless an instrument of revocation has been
recorded.

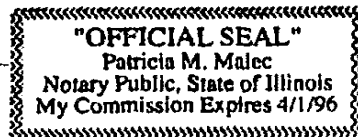
