SUBORDINATION AGREEMENT

That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated reflecting and securing the loan made by Mortgagee to Borrowers, in the amount of Seventy-three Thousand and no/100 Dollars, and to all renewals, extensions or replacements of said mortgage; and

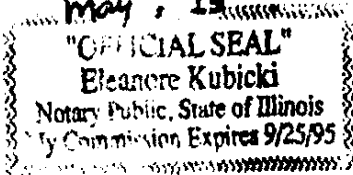
