That part of the Northwest Quarter of Section 11, Township 39 North, Range 12 East of the Third Principal Meridian, bounded as follows: On the East by the West line of 4th Avenue; on the West by the East line of 5th Avenue; on the North by a line parallel with and distant 50 feet Northerly, measured at right angles, from the center line of the main track of the Chicago and North Western Railway Company (now the Chicago and North Western Transportation Company), as said main track center line was originally located and established over and across said Section 11; and on the South by a line parallel with and distant 24 feet Southerly measured at right angles from the South line of Main Street.
